Dave, I absolutely agree that we need to plan for the possibility, that is why I raised it yesterday. I'm afraid I'm sure I agree with your proposed methodology.

Richard,

At this morning's Tram IPG we had a discussion following your update on Project Carlisle yesterday.

In order to for us to plan for the future in the most complete manner, I can confirm that Marshall will pull together a group involving Alan, Nick/Carol and Andy to develop a contingency road map of key steps that would need to be taken to deal with the now very real prospect of a need to move to contract termination.

In order to facilitate this work I would intend that the group discuss legal matters with Andrew Fitchie and also begin work with tie, with Stewart McGarrity presumably as your lead in this area, on planning for the eventuality of contract termination, followed either by re-procurement and /or tie step in; or by contract termination, followed by project termination.

In addition, I will ask Marshall and Alan to contact Tony Rush with a view to gaining an understanding of the price parameters for project Carlisle; the design related issues which underpin the proposed price and to discuss what scope exists - through negotiation and value engineering - to get to a reasonable value for money outcome from where things currently stand.

I hope that the plans for termination may not be required but I am sure that you realise our need to begin detailed preparations for this eventuality.
