You will have received today correspondence from the tram consortium in advance of tomorrow's Council meeting.

In light of the current dispute and the potential mechanisms for resolving that dispute, the consortium is (as would be expected) attempting to protect its position as much as it can.

Extensive legal advice has been sought by tie in relation to all disputed matters. Council officers are also seeking independent legal advice to protect the Council's position as project guarantor.

Whilst it is a matter for tie, I do not consider it to be wise for tie to agree to release the formal adjudication decisions at this time. These decisions are highly complex and need to be read against the full factual background and the full terms of the contract.

In order to protect the best interests of the Council, tie, the project and the public purse, it is imperative that the dispute is resolved by both parties following the appropriate contractual mechanisms. It is also important that nothing is done at the present point in time which could prejudice tie's or the Council's respective positions. Accordingly, I recommend that no response be made to this letter and that no contact be made with BSC (or their representatives) by Councillors. Instead, an appropriate response will be sent by tie as counterparty to the tram contract and also by me on behalf of the Council.

I will be around tomorrow morning so if you have any queries or would like to discuss this further do please let me know. Meanwhile if you could make other members of your groups aware of this position that would be much appreciated.
