- 1. This is really an aide memoir to myself and a dump in one email and attachments of everything I know or have about BB and S pricing make-up. The pricing make up we have is based upon the attached 3 BB documents sent to Dennis by Scott McFadzen in Feb 2008. They are all password protected and the password is **vierendee**l. The total of the schedule is **£218,262,426.00** ie the price after Weisbaden.
- 2. The basic Civils price per this analysis is £135.944m split £89.073m on Airport to Haymarket and £46.922m on Haymarket to Newhaven. This is before adjusting for various other items such as VE taken into the price and adding in the provisional sums. I don't know if we have ever done an attribution of these items to each of Civils and Systems and/or between the on and off street sections?
- 3. The easy reconciliation from Weisbaden to the Construction Works Price in Schedule Pt 4 is....

- 4. The Siemens price per the schedule is £91,510,000. The Siemens price make up I have is attached it totals to £96,917,006.78. I can't reconcile from one to the other but the differences will again be VE, Provisional Sums and Siemens share of the various pre-contract increases.
- 5. A straight analysis of the Milestone Schedule (also attached) shows that the Construction Works Price excluding the Provisional Sums is £219.162m divides up £123.184m to BB and £95.978m to Siemens.
- 6. All of the above is before allocation to each of Civils and Systems and/or between the on and off street sections of the changes which have been approved/agreed since contract close and the final accounting for the PSSA.
