



# EDINBURGH TRAM Highlight Report to the Chief Executive's Internal Planning Group 30 September 2009

# 1 Background

This 'highlight report' is an update to the Chief Executive's Internal Planning Group (IPG) on the Edinburgh Tram Project to inform on the progress on this project and any decisions required.

A version of this report (with commercially sensitive and confidential material removed) is also to be circulated within the Council as a means of communicating progress with the Tram project.

# 2 Executive Summary

### 2.1 Matters Arising

# Council Reports to the Council Committee's

A summary of the reports presented is provided, which includes the strategy for the tram Traffic Regulation Orders, when buses will be returned to Princes Street, and tram governance matters.

# **Evaluation of Financial Contingency Measures and Strategic Options**

An update is provided the financial contingency measures, plus identification of Council financial pressures that have arose from the implementation of the tram.

# Tram Monitoring Officer Update

An update on the Dispute Resolution Process (DRP) and a summary of DRPs is provided.

# **Communications Update**

An update is provided on the ongoing *Open for Business* initiative, particularly in relation to the upcoming Winter Festival, and on related issues including the Leith Newsletter, EHLiving and Transformers.

# Tram Legal Agreement with Forth Ports

The legal agreement between the Council and Forth Ports remains unresolved with no agreement being reached on the detailed terms of the agreement.

# Winter Festival Events

An internal group is to be set up to review operational matters related to the Winter Festivals.

# Statutory Council Approvals and Consents

As the detailed design continues, there are several statutory consents that the Council must provide. These include Planning Prior Approvals, Building Warrants, Roads and Structures Technical Approvals.





# **Building Fixings**

Good progress has been made with the court action for the building fixings. The first hearing is anticipated to be on 9 October.

# Land Acquisition and CAADs

To note that applications for Certificate(s) of Appropriate Alternative Development (CAAD) are expected from a number of land owners and it will require close co-operation between Planning, Corporate Property and Legal Services in dealing with them.

# 3 Council Reports (Presented by Dave Anderson/Jim Inch)

## Transport, Infrastructure and Environment Committee on 22 September

A report was presented that details the proposed strategy of the promotion of the tram Traffic Regulation Orders and comprises:

- A three stage strategy which will implement the essential tram TROs as quickly as possible followed by two further stages what deal with the concerns and objections received.
- Consultation will commence with emergency services on 12 October. In the interests
  of openness, the drawings will be available to the public from this date.

The report was approved.

# Policy & Strategy Committee on 29 September

Two reports were presented that dealt with the decision when to return buses to Princes Street and changes to the Tram Governance and approval by committee of the Memorandum of Understanding and the revised TEL Operating Agreement. Once approved the transfer of **tie ltd** shares can be implemented.





# 4 Evaluation of Financial Contingency Measures & Strategic Options (Presented by Donald McGougan)

A request has been formally made to **tie Itd** to review the strategic options paper. **tie**'s response will be reported to the group when it is received.

Transport Scotland has now been made aware at the highest level of the options the Council are considering for contingency planning purposes.

The current thinking on contingency planning is that in the absence of a revised estimated outturn cost, contingency planning will take place around hypothetical assumptions of 5% and 10% on the current funding level. The Council will also have to plan around the risks in the S75 contribution from Forth Ports and the assumption this contribution may not come to fruition

Any view on a potential overspend on the £545m funding envelope will need to be informed by results from the Dispute Resolution Procedures and other contractual processes that **tie Itd** are now putting in place.

Through the Prudential Framework a notional contribution from the TEL Business Plan to the Council of £2.3m p.a. over 20 years would allow Council borrowing (and a further contribution to the project) of around £28m. Taxation considerations may allow more benefit to be gained from such an arrangement. This could cover a 5% threshold. Further borrowing would incur costs of a similar nature which would push out other opportunities from future years Council Revenue or Capital Expenditure plans.

More work is required as the contractual process develops and more security is realised on the estimated cost.

#### Council's £45m Contribution

This section updates the group on the Council's funding for its £45m contribution to Phase 1a of the tram project. A review of the Council's funding strategy; specifically in relation to developers contributions will take place on a six monthly basis. This review will be conducted in-house using existing resources from Finance and City Development. The position is unchanged from the previous report and is:

# **Council Financial Pressures**

A number of third party funded projects are flowing through the tram project. These projects range from agreements such as Forth Ports and the RBS tram stop, which are funded by the third party, to miscellaneous items of design that the Council has requested. These design elements are out of scope of tram design and are now payable by the Council. The range of third party items is listed below.

It should be noted that the highlighted items have no current funding and will become a pressure on the Council budget.

It is recommended that the IPG decide how best to proceed with the additional costs.

5 Tram Monitoring Officer (TMO) Update (Presented by Marshall Poulton)
The table below provides a summary of the Dispute Resolution Process (DRP).

The approximate value of each DRP is noted below (though it should be noted that the value of a DRP principle may significantly differ from the value of the DRP dispute itself). **tie Itd** are also working on documentation to calculate the maximum period which each dispute could take (excluding any litigation). However, early indications are that we will not have a clear picture of estimated final costs and timescales for some time, perhaps not until well into 2010. This obviously means timing of reporting back to Council with a revised position will be uncertain, but reflects the realities of the dispute. Monthly briefings have been set up with the group leaders and are proving valuable in keeping members informed. In order to keep construction of the project running, numerous disputes may need to be formally initiated in order to allow **tie Itd** to engage the terms of the contract which allow them to force Infraco to mobilise despite there being disputed issues.

# 6 Communications Update (Presented by Isobel Reid)

# Princes Street signage

Following consultation with local traders in the Princes Street area signage is being cleared from the west end of Princes Street now that the main track works are progressing further towards the mid- to east end.

Two new signs have been designed to be placed at the Princes Street junctions with Hanover Street and Frederick Street advertising the businesses on these two streets. These signs will be installed next week. This was welcomed by the retailers in these areas.

In addition, *Open for Business* signage was designed and produced for Frederick Street, Murrayfield and the Conan Doyle bar and banners were made for the Edinburgh Festival firework display.

### Winter Festival

A Marketing and PR working group has been set up comprising professionals from DEMA, City of Edinburgh Council, *tie* Ltd, Open for Business and retailers in the City Centre.

The group are currently working on a promotion of 'Edinburgh Sparkles', a UK wide winter marketing campaign. The key messages of this campaign include:

- a) Promotion of Edinburgh as a must-see, magical shopping destination
- b) A unique shopping experience not to be missed at Christmas time
- c) Easy to navigate with lots to see and do perfect for shoppers who also want to enjoy themselves.

Confirmation on the size and scope of the campaign is still to be agreed.

The City of Edinburgh Council is working together with 'She's Gott It' and 'Unique Events' to ensure the promotion of both Edinburgh's Christmas and Edinburgh's Hogmanay. Details are being finalised.

# **Tram Information Boards**

One side of all the Tram Information Boards currently on street across the city has been changed to a new design as they included the strapline 'Taking you to the shops/work in 2011'.





# **Open for Business**

# Winter / Christmas activity & DEMA

- OFB has continued to work in collaboration with DEMA on the Xmas and Winter plan. The updated proposal was presented at the Winter Marketing Campaign meeting on Tuesday.
- Burt Greener has been obtaining costs for a radio advertising campaign to run alongside the activity.
- Burt Greener will be emailing out to retailers asking for them to notify them about special events around the official start of Edinburgh's Christmas on 26 November.

Leith newsletter - The first newsletter has been produced and is currently being distributed in the Leith area.

**EHliving** - The proof for the Autumn/Winter 09 issue of EHliving has been circulated to the OFB group. Feedback will be collated next week so that the magazine can go to print in a week's time. The magazine will be inserted into the Edinburgh Evening News and distributed widely throughout Edinburgh and the Lothians from the start of October.

# Removal of the Paolozzi Sculptures, Picardy Place

The sculptures will shortly need to be removed in readiness for the Tram Infraco works. Although they do not lie within the direct path of the Tram infrastructure, the landscaped area to the front of the Cathedral will be removed to allow for major changes to be made to the Picardy Place road junction.

A new area of public realm will be created within the centre of Picardy Place. The layout of this area is still to be finalised as this relates to future development proposals which are now being considered for the wider site.

*tie*'s contractors are currently estimating October/November for the removal, subject to agreement of a finalised Method Statement with CEC Planning.

Local Councillors were briefed on Wednesday 16th September on the proposed removal of the Paolozzi sculptures.

### **Schools Programme**

**Tramformers (Junior Tram Construction Advisors)** - Communications staff from CEC and *tie* Ltd have been visiting schools since the start back of term to introduce the Tramformer scheme and to discuss with the P6 pupils how they can get involved.. Presentations have been conducted at 17 primary schools in Edinburgh

The aim of the Tramformer programme is to involve primary schools in the work of the tram project in a practical and fun way. Each participating school selects two pupils from P6 to be





a Tramformer for the year. Tramformers will learn about the tram project and will be encouraged to discuss the project with their fellow pupils.

The schools programme team has also been involved in running workshops in conjunction with Scottish Businesses for Communities. The pilot programme ran at Craigroyston High School this month, 8 workshops were run to a total of 80 Primary 7 pupils.

# 7 Tram Legal Agreement with Forth Ports (Presented by Andy Conway)

The Council have not yet managed to agree the revised legal agreement with Port Ports (FP) and this is impacting construction progress. The Director's of City Development and Finance met with Charles Hammond from FP on the week commencing 14 September, but limited progress has been made.

It is recommended that a further meeting is held at a Directorate level with FP to resolve this.

# 8 Winter Festival Events (Presented by Dave Anderson)

Following the success of the internal summer festival mitigation group, which was made up of staff from a variety of Council sections, it is proposed that a similar group be established to review the operational matters related to the Winter Festival events.

# 9 Statutory Council Approvals and Consents (Presented by Andy Conway)

The table below provides an updated summary position on all the necessary approvals required from the Council for the tram project. A further detailed breakdown is attached as Appendix 1.

An approvals tracker that identifies each of the approvals and their status has been developed. An extract from that tracker is also included as Appendix 2. The status of the approvals relates to the Issue for Construction drawings which is on the critical path for the project construction. However, there remains many 'conditioned matters' that need to be closed out. A programme is awaited from **tie Itd**.





# 10 Building Fixings (Presented by Colin Mackenzie)

Court action has commenced against nine of the owners along the route. The Sheriff has granted a warrant to the Council to serve a Summary Application (writ) on each of these owners. Instructions were given to Sheriff Officers on 10 September to serve these papers on the owners. In each of these cases the first hearing is scheduled before the Sheriff on 9 October. At that hearing the Sheriff will determine further proceedings depending on the approach taken by each of the owners.

Of the remaining cases which required Court action, one owner has intimated she will now grant consent. Discussions are ongoing with solicitors/ factors for another three owners. Failure to secure consent within the next week will result in Summary Applications being raised against these owners. An amended plan has been received from tie in respect of the building at the corner of York Place and Dublin Street which will allow the Summary Applications (four owners) to be finalised and lodged with the Sheriff Clerk immediately.

# 11 Certificate of Appropriate Alternative Development (CAAD) (Presented by Marshall Poulton)

CAAD applications are expected as part of the negotiation of compensation claims for the tram project; a single application at Haymarket Yards, several at the Airport and CALA's existing application for Ocean Drive.

These applications are relatively rare, and are governed not by planning law but compensation law.

Liaison has progressed between Planning, Corporate Property and Legal Services to assist planning department officers to become familiar with all aspects of the CAAD process and its application to compensation.

The purpose of a CAAD is to inform the compensation process by assisting the valuers set the basis of valuation. The decision has to be considered against the background of a hypothetical "no scheme" world and there are a number of cases which inform what that world consists of.

Following a CAAD decision a valuation may still be in dispute and the case can be referred to the Lands Tribunal, where the CAAD is likely to form part of the valuation dispute and our Planners would provide expert witness to support the Councils case.

Each CAAD can have a significant financial impact. They are normally utilised where development value is thought to be possible by the claimant. This often leads to a wide margin of value between the valuations of the Acquiring Authority and the Claimant.

The District Valuer's estimates are based on planning advice obtained from the planning department and form the basis of the *tie* budget for land compensation.

We have only one compensation claim actually lodged for lands which might be affected by a CAAD, NIL's lands close to the Airport, where the DV's estimate was based on around £100,000 per acre, but the claim is based on 5 times that, a total of £11.5m. This is indicative of the effect positive CAADs might have on the budget and leads to a worse case estimate of an additional budget requirement of £25m.
