Further to our discussion this morning I would appreciate a speedy resolution to funding of the recent £3.2m payment to BSC as a result of Phase 1b not proceeding.

This payment is not a cost relating to Phase 1b! The £3.2m was a negotiated discount on the Phase 1a price at Financial Close relating to BSC's demobilisation costs. At Financial Close a report went to the Tram Sub Committee of the Council clearly stating that the cost of Phase 1a is £515.2m with a price reduction of £3.2m in the event Phase 1b proceeds.

As a further point, the current application process was set up with the understanding that Transport Scotland could approve the application in part, reserving the right to withhold certain elements should they require further detail or evidence. Therefore I cannot understand why the whole of the last application had to be resubmitted rather than simply withholding the amount you have issue with.

Finally, can you confirm that the amount recently approved will be paid into our account on Friday as expected. We have to keep a careful eye on cash flow due to the £3.2m being paid out in advance of TS funds.
