Please refer to letter Ref; AMIS/tie/letter/KAG/Projects/1000 dated 6th May 2008 in connection with the above.

Following discussions and the exchange / review of various hitherto uncontrolled documentation between our Mr. Keith Gourlay and your Mr. John Casserly, AMIS MUDFA have, subject to the appropriate approval and endorsement of tie Limited, concluded negotiations with Grontmij Limited on the provision of Design Services at Section 7B.

The acknowledged difficulties associated with instructing a Design and Build mackage under the MUDFA terms and conditions, where Design responsibility is not the responsibility of the MUDFA Contractor, have still not been addressed.

AMIS MUDFA request that tie Limited address this aspect as a matter of some urgency.

Further to my email of 21 May and our subsequent discussions please find attached the updated Contract Data. As agreed, the amendments are:

- The period of retention of documents has been increased from 6 years to 12 years
- The defects date has been increased from 26 weeks to 2 years
- The Consultant's total liability has been increased from £1M to £10M.

Do you want to amend the actual start date? We have done a little work over the past 2 weeks in good faith to ensure we would be ready for the first workshop. Do you have a revised date for that yet? As advised before the £8500 mobilisation cost covers only work up until 30 April.

Also as discussed the additional insurance premium will be doubled to £2800 to cover the amended conditions above. This affects Clause 7 of the Scope and I attach an updated version.

1 INTRODUCTION

Alfred McAlpine Infrastructure Services Ltd (AMIS) has requested that Grontmij Ltd submit a fee bid for Consultancy Services associated with the Multi-Utility Diversion Framework Agreement (MUDFA) for the Edinburgh Tram Project – Section 7B. This bid is for:

- Phase 1: Investigation and confirmation of existing utilities
- Phase 2: Detail design of protection works of existing utilities
- Phase 3: Detail design of diversions of existing utilities
- Phase 4: Site Liaison/attendance, design support during the construction phase and production of as-built drawings

The above is based on the schedules and drawings as provided in a copy of the report provided by AMIS: Statement of Requirements Section 7B - MUDFA Works, dated 01/10/07

SDS Provider will remain and fulfil the role "Edinburgh Tram Design Authority" for the overall project including Section 7B, and will review and approve all Designs, Engineering and RAT's proposals presented by AMIS MUDFA

tie Limited will ensure that all parties associated with Section 7B MUDFA utilities are coordinated in a planned, systematic and controlled manner and will remain responsible for the technical and commercial approval of all diversion and protection proposals and utility deliverables to support AMIS MUDFA in accordance with the Construction Services Programme, Revision 06 (September 2007)

2 CONDITIONS OF ENGAGEMENT

Grontmij Ltd will be appointed under the terms of the NEC 2 Professional Services Contract, main Option E (Time based). The Contract Data Form will form part of this Agreement.

3 SCOPE OF SERVICES

3.1 Phase 1

Phase 1 consists of the investigation of existing utilities along the Edinburgh Tram route for Section 7B, i.e. as detailed on drawings provided by AMIS (drawing Nos: ULE90130-07-TVA-00008-rev3 and ULE90130-07-TVA-00007-rev3 forming part of the report: STATEMENT OF REQUIREMENTS SECTION 7B – MUDFA WORKS, dated 01/10/07),

and also the confirmation of these utilities by means of the fellowing:

- PU Drawings (provided by AMIS)
- BAA Engineering Drawings (to be provided by AMIS)
- Aiden Survey (provided by AMIS)
- Local knowledge from service providers



- Jacobs drawings
- Trial investigations scoped up by Grontmij Ltd to be undertaken by AMIS or other appointed by AMIS.

The above will be issued to AMIS for approval and for comments to be incorporated in the deliverables.

It is understood that Grontmij Ltd will be involved in a workshop (or workshops) with all stakeholders to comment on the above.

The Phase 1 deliverables to AMIS will consist of a report and drawings identifying the following:

- Confirmation of known utilities
- Utilities of which information is doubted after the aforementioned methods of confirmation
- Notes and assumptions by Grontmij Ltd

3.2 Phases 2 and 3

Phases 2 and 3 consist of the detail design of protection and diversion works of existing utilities as might be required due to the Edinburgh tram for the section 7B of the track (see drawing Nos: ULE90130-07-TVA-00008-rev3 and ULE90130-07-TVA-00007-rev3 forming part of the report: STATEMENT OF REQUIREMENTS SECTION 7B -- MUDFA WORKS, dated 01/10/07).

The existing utilities listed in the Baseline Schedule in Appendix 2 of the above report forms the basis for this proposal.

3.2.1 Phase 2: Detail Design of Protection Works

The objectives are to produce drawings and/or schedules, a Bill of Materials (template to be provided by AMIS) and specifications detailing protection works required for:

- existing utilities where diversion is not required as per the Baseline Schedule, and
- allowance for ducting/sleeving, i.e. where any uncertainty may exist regarding the requirement for such and to be clearly marked for this purpose on all design deliverables.

The latter is not quantified and will be rolled out through the workshops with all stakeholders.

3.2.2 Phase 3: Detail Design of Diversion Works

The objectives are to produce drawings and/or schedules, a Bill of Materials (template to be provided by AMIS) and specifications detailing diversion works required for:



existing utilities where diversion is required due to the location of the Edinburgh
 Tram track and kinetic impact thereof on the ground, as per the Baseline Schedule.

It is understood that there may be additional requirements for diversion of services and that this will be clarified during detailed design.

Once all the above design is approved by SDS Provider then all deliverables shall be issued "For Construction" to AMIS. The issue of information shall be staged due to the criticality of meeting the programme for construction.

3.3 Phase 4

Phase 4 consists of site liaison/attendance and design support during the construction phase. The construction phase is to be confirmed by AMIS.

The scope also includes for the production and issue of As-Built drawings following completion of construction.

4 KEY ASSUMPTIONS

- Grontmij Ltd will be responsible for investigation of existing utilities and confirmation
 of their location, capacities, sizes and quantity. Grontmij Ltd will provide drawings
 and report to convey such information to AMIS. Grontmij Ltd will be responsible for
 management of this Scope; however Grontmij Ltd will be required to liaise with others
 through AMIS.
- The provisional programme is based on issue of information to Grontmij Ltd within a maximum of five working days from request of such information. All information will be requested through AMIS.
- Tram track alignment is as per the report: STATEMENT OF REQUIREMENTS SECTION 7B - MUDFA WORKS, dated 01/10/07.
- Tram track location will be marked out by AMIS on site (or other appointed by AMIS) or drawings to be provided by AMIS with location for Section 7B within five working days of agreement to this contract or issue of acceptable work order.
- Where information has been provided by utility owners and confirmation of such utilities, due to site restrictions (e.g. access or inability to locate during site investigation) cannot be achieved, the utility owner information will be assumed as correct.
- Access to site for any non-intrusive investigations will be granted within a maximum of two working days from request.
- AMIS will be responsible for the management of intrusive site investigation works for confirmation of such utilities identified by Grontmij Ltd. Required Notices for any road works to be managed by AMIS. Grontmij Ltd will not be responsible for any delays in the management of such investigation works.



- Any stakeholder approval/comments to be provided within a maximum of five working days from request by Grontmij Ltd. Grontmij Ltd will not be responsible for any delays caused by a request for additional information to this Scope or extended approvals required by other designers, statutory consultees and other stakeholders.
- No allowance is made in estimated fee or programme for any interim information AMIS might request as interim proposals e.g. as proposals to other parties before final drawings are ready as per programme dates.
- AMIS will make available accommodation facilities during the period of the contract. Branded PPE e.g. hard hats, high visibility jacket etc. shall be provided by AMIS.
 - The cost relating to these accommodation facilities and PPE has not been allowed for under this proposal and shall be deemed to be included for by AMIS under their construction works contract.
- Grontmij Ltd will be responsible for issuing their detail design (as per section 3.2 of this report) by means of drawings and/or schedules, Bill of Materials and specifications to AMIS for approval by SDS Provider. It is assumed that the approval periods are to be a maximum of five working days for detail design deliverable on phase 2 and a maximum of ten working days for phase 3.
- The information provided by AMIS in the report: Statement of Requirements Section 7B - MUDFA Works, dated 01/10/07 forms the basis of the activities allowed for making up the cost and programme for this proposal.
- All intrusive site investigation work required for\during \(\text{detail} \) design shall be the
 responsibility of AMIS. There are no intrusive site works identified or allowed for
 under this proposal. All sampling and testing of in-situ \(\text{ground} \) for contamination is
 assumed to be outwith Grontmij Ltd's Scope.
- Responsibilities resting with other stakeholders as identified in the above mentioned report provided by AMIS will be fully discharged.
- tie Limited will perform the role of CDM Co-ordinator in determining and imposing the CDM Regulations and project specific requirements pertaining to utility services planning, design and construction activities.

5 PROGRAMME

An outline programme of services is provided in Appendix B.

6 EXCLUSIONS

- Grontmij Ltd will not be held responsible for the existing performance of the utilities
 or any damage, claim or consequential loss that may arise from any works carried
 out by others.
- Grontmij Ltd will not be held responsible for any consequential loss to the Edinburgh Airport due to any works under the Edinburgh Tram project.
- Grontmij Ltd will not be held responsible for any delay or consequential loss to MUDFA or any associated subcontractors due to any works under this contract.



- Grontmij Ltd will not be held responsible for any delays caused by utility suppliers in
 making available any information or comments within the stated five days and ten
 days for respectively phase 2 and phase 3 designs.
- Grontmij Ltd will not be held responsible for any loss\damage caused by others

7 COSTS AND INVOICING

The estimated fee for this contract is £220k, which is detailed in Appendix A. This excludes the agreed mobilisation fee of £8500 which covers Grontmij costs up to 30 April 2008.

The cost of the additional PI liability (£10million) required for this contract will be charged to AMIS as a reimbursable expense at the completion of the services.

 - "11.2(10) A Defect is a failure of the *Consultant* to perform the Services in accordance with clause 21.2 or the applicable law at the time of performing the Services"

Z2 The Consultant's obligations 21

Clause 21.2, insert the following at the end of the sentence:

"and not withstanding any other provisions of this contract (whether express or implied) the *Consultant* shall not be liable in respect of any greater obligation, including (inter alia) achieving fitness for purpose or suitability of use."

Z3 Working with the Employer and Others 23

Insert new clause 23.3:

- "23.3 If, as a direct result of the *Consultant's* failure to comply with 21.2, the Services do not meet the Condition stated for a Key Date by the date stated, and, as a result, the *Employer* incurs additional cost either
 - · In carrying out work; or
 - By paying an additional amount to Others in carrying out work

on the same project, then subject always to the *Employer* mitigating any such additional cost, the reasonable additional cost that the *Employer* has paid or will incur shall be met by the *Consultant*. The *Employer* 's right to recover the additional cost is his only right in these circumstances."


