I have forwarded for information. Willie Gallagher has called to discuss. In essence BBS are advising that they need a further period of time for their own due diligence, focussing on Employer's requirements and the novation issue from SDS to BBS. Current timeline now showing additional time to approx mid February will be required by BBS before conclusion. WG is expecting to receive further information that this will be at no cost or delay to the project. We will receive further details at Tie/TEL Boards today. There will now be a further period of time before you are asked to use your delegated authority. In terms of communication, WG is planning brief communication to Group Leaders advising that BBS require more time for their own due diligence but that he will be requiring BBS to meet this plan and that the expectation is at no cost to the project. There are some advantages in allowing more time for our own completion issues. We have our internal IPG meeting on Thursday where we can update further.
