I am considering from a public disclosure standpoint whether it is appropriate to append this to the Council report. It gives information about what our perception (as **tie's**/CEC advisers) of the progress of the negotiations has been and is therefore helpful to BBS in terms of tactics from now until close.

I understand that how Report would be used and is required to underpin Council officers' opinion, but I am of the view that it would be better to summarise in the Report itself that the Council Solicitor has had legal advice on these matters and is satisfied as to how they are being treated commercial and contractually. The report is, in the end analysis, advice to the Council about how the project is reaching close.

My view is that it would be prudent not to disclose this Report for BBS to read as an annex, if this would be the case.
