I have received and compared both SDS's and BBS's comments on the draft design scope split that I circulated on 21 January.

The attached spreadsheet sets out both sets of comments. Wherever these are exactly aligned I have filled in the lines grey leaving only those in white where there is some form of difference. That difference might be:

- differing view about which party is best placed to undertake the task
- comment by one party or the other
- one party has not completed the column for who is best placed to undertake the task

You will see that about two-thirds of lines are grey so there is significant agreement. Many of the rest are either activities where SDS has not included a response because the activity is complete or where the comment seems uncontroversial. These should be able to be greyed out very quickly.

That leaves a smaller core of issues that we need to debate and bring to a conclusion.

I would like to facilitate a further meeting between BBS and SDS in the first half of next week to bring this to a conclusion. Could you please confirm when SDS representatives would be available.
