I am becoming increasing concerned about MUDFA - it may be that I'm out of the loop so apologies for butting in if I am.

I know that Graeme Barkley is joining tie - this week? - however if we are to start the trial works on 2 April, we need to ensure that the following is in place:-

- access rights both to the land within the LODs and any land required outwith the LODs while in relation to Casino Square we can negotiate an agreement with Forth Ports, there are certain things which we must do at least 28 days in advance of the works. In addition as I pointed out previously some of the works will require access to land outside the limits of deviation. Who is leading this/taking ownership. This has not been raised with the land and property team and securing land rights always takes longer than you think.
- traffic management Keith has concerned about this and how this is progressing. He is particularly concerned about advance/remote signage and who is responsible for this. So far nothing has been done to provide this however I think on Friday Keith engaged Sandy Williamson to try to develop a strategy. AMIS do not think this is their responsibility.
- communications the frontager surveys are patchy in places and there has been no visibility of how the comms process is working.
- Casino Square can we use this for the trial site given the terms of the FP and MUDFA Agreements?

There are probably other issues - these are the ones which have been drawn to my attention. Given that the MUDFA Agreement is remeasurable it is essential that we do not cause delay.
