I have just been talking to Keith Bishop who is going to speak to Tom this afternoon about utilities.

Listed in the scope of services for the SDS Provider are various services associated with utilities including design. We need to consider what happens with regard to design liability for utilities pre and post novation. Will the liability for design of the utilities rest with the contractor appointed to carry out the utilities works or will a collateral warranty be required from the SDS Provider?

Also, we need to consider the SDS Provider's responsibilities vis a vis Network Rail.

Speaking to Dave and Gerry yesterday, they mentioned that they had not read the technical specs or the scope of services, although they have given input on/drafted certain sections. The exercise of doing a page turn of the SDS Contract on Tuesday should flush out issues such as utilities and Network Rail but I suggest that the team will need to do a detailed review of the whole package of documents to make sure that everything hangs together properly.
