Bilfinger's milestones end Feb-14 and the Siemens milestones March to May-14 are c. £1.7M.

Further savings could be achieved by making inroads into the Rev3A/Rev amounts however this is complex as it has been subject to IC opinion, agreement by CEC to the Infraco milestone schedules which were phased Jan to Dec-13 and front loaded.

Previous discussions last year would have been before the decision was made on the 22 weeks £6.45M and would have assumed a combination of saving from this item, part of the rev3A/rev 4 £4.5M and contract milestones Feb to May-14
