We agree that the way Mark has presented these numbers accurately reflects the current position of the parties. We would, however, make the following comments, recognising that your original decision required each instance to be reviewed on a case by case basis:

PMC 77a (setts) - although the spreadsheet indicates that this PMC has a net negative value, when combined with PMC 77b, the overall value of setts on the project has increased, resulting in an increase to Bilfinger's prelim and overhead contribution (overall £175k add, £159k omission). We therefore consider applying the contract markups on the entire change to be fair.

PMC 206/224 (Cathedral Lane) - as with PMC 77a, the overall result of the Cathedral Lane change is an increase to the contract sum and therefore an increase to Bilfinger's prelim and overhead contribution. We therefore consider that applying the contract markups to the entire change to be fair.

PMC 225 (Hope Street) - we would accept a markup of only 10% on the net (negative) value of the change as a reasonable position but do not see why the adds should be marked up at a different rate than the omissions.

PMC 295 (Additional 22m of track) - as with PMC 77a, this is part of a much larger, positive change (the York Place turnback), which will result in an increase to Bilfinger's prelim and overhead contribution. We therefore consider that applying the contract markups is fair.

We would be keen to discuss this with you on Monday before you issue your position.
