6 Council Budget 2011-14

A strategy for the development of the Council's budget for 2011-14 was proposed. Details were given of the approach being taken to identify the necessary savings to meet the potential reduction in Scottish Government grant funding during this period and proposals for public engagement on the Council's service priorities and budget choices.

Motion

To recognise that this state of affairs had led to a formal warning to Council from the Director of Finance.

- (ii) the phased approach to developing the budget for 2011-14, including the proposed strategy covering priorities, people, procurement, processes and property.
- (iii) the Chief Executive's intention to develop a detailed budget timetable to include elected member briefings and, as part of this, to report on a proposed Budget Communications Plan to the Council meeting in June 2010.
- (iv) the Chief Executive's intention to report later in 2010 on the management delayering proposals and resultant cost savings.
- (v) that the Director of Finance would provide further reports on the Long Term Financial Plan and the Capital Investment Plan and that a report on progress in developing the 2011-14 budget would be made to the September/October meeting of Council.
- (vi) the proposal to set a budget for 2011-12, 2012-13 and an indicative budget for 2013-14 in February 2011.

11 Duddingston Village – Traffic – Motion by Councillor Ewan Aitken

The following motion by Councillor Ewan Aitken was submitted in terms of Standing Order 28:

"Council notes:

- the considerable traffic issues in Duddingston Village caused by the use of Old Church Lane and the low road through Holyrood Park as a de facto arterial route for the city;
- the fact that this route is totally unsuited to play this role in the Edinburgh traffic network;
- that discussions on these issues go back over 20 years;
- the recent series of meetings between Historic Scotland, Police, City Development and Services for Communities to try and devise a way forward;
- recent discussion at the Craigentinny/Duddingston Neighbourhood Partnership and its Environmental Subgroup on the issues;
- that Council officers had been able to make some small adjustments through, for example, signage and road adaptation but have not had the authority to make significant strategic input into the discussions;
- that all these discussions have concluded that this issue needs to be set in the context of a wider, strategic discussion on arterial routes in the city.

Council agrees:

- to call for a report on the consequences of changing Old Church Lane and the Holyrood Park low road from a de facto arterial route into the city;
- that this report needs direct input from Director level in the relevant departments in partnership with the Police and Historic Scotland. This input should involve residents meeting with the relevant directors."

The Lord Provost remitted the motion to the Transport, Infrastructure and Environment Committee in terms of Standing Order 28(3), subject to competency.

12 Aung San Suu Kyi – 65th Birthday – Motion by Councillor Hinds

The following motion by Councillor Hinds was submitted in terms of Standing Order 28:

"Council notes the 65th birthday of Aung San Suu Kyi on 19 June 2010.

Council further notes that it is five years since the City of Edinburgh Council awarded her Freedom of the City.

Council deplores the injustice and inhumanity of her treatment and the suppression of her democratic right to freedom of assembly and expression of thought.

Therefore, Council agrees that:

- The Lord Provost will send birthday greetings from the City of Edinburgh to Aung San Suu Kyi;
- The Lord Provost/Leader of the Council will contact the new Foreign Secretary to ensure the continued support of the British government in working for her release."

QUESTION NO 1

By Councillor Johnstone answered by the Convener of the Transport, Infrastructure and Environment Committee

Question

(1) How many metres of <u>dedicated</u> cycle lane exist on Edinburgh's roads? This figure not to include off-road cycle paths, for example, the Meadows, Union Canal, Water of Leith walkway etc and should only include marked cycle ways that cannot be parked upon by vehicles at any time.

Question

(2) How many metres of marked cycle lanes have parking bays on them?

Question

(3) How many of these bays have been created *since* the cycle lanes were installed (for example Gilmore Place)?

Answer

There is a total of approximately 20km of on-road cycle lanes in the city. However, the level of detail requested cannot be provided within the timescale for this Council meeting. I shall write to Councillor Johnstone as soon as the information has been collated and report it to the Council.

QUESTION NO 2

Question

Please advise on progress being made with respect to allowing public use of school sports facilities through Edinburgh Leisure.

Answer

This matter is being progressed through the Community Access to Schools Working Group. A further report will be presented to the Education, Children and Families Committee in September 2010.

QUESTION NO 3

By Councillor Buchan answered by the Convener of the Economic Development Committee

Question

What proposals is the Convener aware of for the 2010 Canal Festival and is he aware of when and how the South West Neighbourhood Partnerships and local Councillors will be made aware of any such proposals and plans?

Answer

The Canal Champion has been informed that the 2010 Edinburgh Canal Festival will be held on 26 June 2010 at Edinburgh Quay.

A Festival Steering Group has duly been reconvened and a draft programme has been developed. Detailed proposals are being finalised.

With the draft programme now available, the Festival Steering Group will approach a range of partners, including the South West Neighbourhood Partnership (SWNP).

The Festival Steering Group will keep SWNP fully informed and involved in the continued planning and promotion of this event. In turn, the SWNP will be asked to make the local Councillors aware of proposals.

QUESTION NO 4

By Councillor Hart answered by the Convener of the Transport, Infrastructure and Environment Committee

Question

How many school crossing patrols were there in 2007/08, 2008/09, 2009/10 and the current year?

Answer

The average number of School Crossing Guides in 2007/8 was 190.

The average number of School Crossing Guides in 2008/9

The average number of School Crossing Guides in 2009/10 was 180.

This current year there are 180 School Crossing Guides

Supplementary Question

Thank you very much to the Convener for his response to my question about school crossing patrols. Is the Convener comfortable with the £20,000 cut to the school crossing patrol budget which means that there is a loss of 20 school crossing patrols across the city and that officers have been told that these vacancies should not be filled and that this therefore compromises children's safety on their way to and from school.

Supplementary Answer

Thanks for the question. Given that that was also in your budget I would ask you the same question back.

QUESTION NO 5

By Councillor Ewan Aitken answered by the Convener of the Education, Children and Families Committee

Question

What research-based evidence has the Convener drawn on to support her view that team teaching P1 classes of 36 has the same benefits as those produced in class sizes of 18 with one teacher?

Answer

While there is no research based evidence, the Scottish Government has supported the Department's approach of class sizes of 40 with 2 teachers to ensure all P1 pupils benefited from the advantage of reduced class sizes.

In Edinburgh, a number of our primary schools have organised their P1 classes using a team teaching approach. This provides teachers with excellent opportunities to plan, work, assess and evaluate within a collaborative setting and has elicited very positive feedback. It also provides very good opportunities to develop effective active learning situations and allows groupings of pupils to be more flexible in terms of catering for the individual and group needs of pupils.

Supplementary Question

Can I thank the Convener for her answer. Given that she said she has no academic or paedological evidence for moving to team teaching, evidence that you get the same educational benefits from teaching as is suggested from smaller class sizes, can she explain to the Council why she is suggesting that they are the same thing?

Supplementary Answer

For the record this answer went into print before we actually had found and supplied the evidence of at least three papers that we have on team teaching: "Oh What a Difference Team Makes - Why Team Teaching Makes a Difference", "Collaborative Teaching for Teaching Educators - What Does the Research Say" and "Research on the Effects of Team Teaching Upon Two Secondary School Teachers". I can furnish the member with copies of these papers if they would so wish.

QUESTION NO 6

By Councillor Munro answered by the Convener of the Education, Children and Families Committee

Question

The Convener has intimated that she will make a decision in relation to the future of Duncan Place Resource Centre. When will the Convener reveal her decision?

Answer

The Convener has met with the staff and users group to discuss the issues surrounding the continued use of Duncan Place Resource Centre.

The Users Group are preparing a business case to test the feasibility of them taking on the running of the Centre. Local staff are considering options for the most effective use of all local facilities. Both reports are expected by the end of June.

Supplementary Question

(1) When will the Convener authorise release of the funding for the lift at Duncan Place Resource Centre and is she aware that there is another report, and would she give access to all local elected members, which asserts that work is needed to be done on the roof at Duncan Places Users Group? Lastly will the Users Group be able to access the funding that Stevenson currently supply in rental income for Duncan Place Resource Centre to enable that to be part of their business plan because I understand that that goes directly to Community Learning and Development?

Supplementary Answer

(1)

Councillor Munro at the moment as you know there is work being undertaken not only by staff but by the Duncan Place Users Group who will be coming back to me and officers in the next month and I really do not want to preempt what they might be suggesting or proposing until I see what it is that they are coming up with and what is possible and then from then we will continue the discussions and see what is possible. There is not much point in talking about funding until we actually get some flesh on the bones.

Supplementary Question

(2)

Again in part of the question that I had there Councillor I was asking whether the local elected members could get access or a copy of the papers which asserts that further works need done beyond the lift repairs because that is a point that has been raised with the local elected members.

Supplementary Answer

(2) Yes, happy to share with you. In fact I have asked Property Services to interrogate their statistics. I want to make absolutely sure that what is being suggested that is needed to be done on Duncan Place is absolutely necessary. So I am very happy to share that information with you when we get it back.

QUESTION NO 7

By Councillor Munro answered by the Convener of the Education, Children and Families Committee

Question

Who set the cap for P1 intake for 2010/11 for Victoria

Primary School?

Answer

The Education, Children and Families Committee on 18 March agreed to a 7 class organisation for 2010/11.

Supplementary (1) Question

I am sure the Convener will want to thank her officers for the non-answer to my question. However, is she aware that the Grant Awards and Placements Department are informing local parents that Victoria Primary School is full? Is she aware of that? Secondly, if she is not aware of that will she instruct them to withdraw that remark and that advice to parents with regard to placings and I will give her an example and reason why. There is a family moved into Newhaven Main Street who were informed that Victoria Primary School was full, that the corridors in the upper part of Victoria Primary School were too narrow, there was insufficient toilet facilities. Instead of the two children from that family going across the road to the school and being in the playground by crossing the road, they are now going up the hill to Trinity Primary School. Do you think that is good advice, bad advice and would you ask for a halt to that advice to enable Victoria Primary School to actually continue to increase its roll and to achieve the aim of the seven class school which was put there in place by the Committee in March.

Supplementary Answer

(1)

The Committee decision was for a temporary increase in the roll. The capacity of Victoria Primary is 145 pupils and it should be a six class organisation. Because more pupils had been enrolled we are in the situation where we have more pupils than we would wish for. So it was a temporary measure for one year only to increase the school structure to seven classes. This has meant that a general purposes room has had to be taken back into use as a classroom which is not something which is of an advantage to the school. The school really we believe cannot cope with seven classes and the Committee decided that it would revert back to a six class structure once we had got through this difficult time when we have more children than we really want at that school. It's a very small school.

Supplementary Question

(2) It is just to ask for access for local elected members to the papers which asserts that the school is too small, that the facilities are inadequate because the HMIE report three years ago does not say that and I would ask that she makes these papers available to the local elected members.

Supplementary Answer

(2) You have had your supplementary.
