Thank you for your email and I note your intention to sign MOV4 tomorrow (Friday, 20th May).

The purpose of this email is to try and avert an embarrassing situation.

Who from tie do you expect to sign MOV4?

The tie team have provided advice at various points during the negotiations but have not been a member of the negotiating team. This has been primarily done by yourself and McGrigors. The tie management have written to David on a number of occasions, as far back as, formally, the 20th April raising issues with respect to MOV4. The latest commentary was as late as yesterday. I am being advised however that no-one is acknowledging the comments being made by the tie management with regards to the risks that signing MOV4 exposes.

I fully understand that the tie management could be viewed as risk adverse and 'damaged' by the years of attrition with Infraco. However, some of the points they have raised are legitimate but have not been addressed. These issues need to be 'put to bed' for tie to sign up to MOV4.

Either these issues need to be resolved before tomorrow or, in accordance with the clearly emerging new governance framework, tie needs to be instructed to sign MOV4 as a agent of CEC.
