It's clear that a number of significant issues remains outstanding, with the need in my view for a three party meeting with tie, BBS, and PB to agree the optimum approach. As an initial response to your email I am not comfortable with the proposal that the final detailed resources for Construction Support be agreed post-contract. This topic has been on the table for some weeks but has not been closed out and I believe there may be a significant gap between BBS's expectations and our own proposals. Hence, I believe it is important that any agreement should be secured pre-contract.

I am also concerned with initial feedback from meetings yesterday that there may be an expectation that PB should rework at its cost designs which have already been submitted and paid for in order to meet new BBS requirements. This comes back to achieving clarity of scope and I need to discuss this development with you.


