David,

Just a quick note on how things are progressing

#### Mediation

Mediation is progressing, but with only limited results. Discussions are still ongoing (midday Friday as I write) I am now turning my attention to the meetings with Keysberg and Schneppendahl on Monday, and the board on Wednesday. I was all for calling a halt yesterday, but the team and the mediators have persuaded me to keep going. Not sure yet if we will continue into tomorrow. I have briefed key stakeholders at the beginning of the week and will do so again this pm.

We have swapped proposals and numbers on how to deal with

- BDDI to IFC (based on percentages)
- Other changes, (refer these to independent QS)
- Extension of time 1 (numbers exchanged)
- Extension of time 2 (dates exchanged)
- On street works (based on Princes street agreements)
- Misalignment Issues –Siemens design interface with BB( they think ours, we think half ours, half theirs
- Value engineering (numbers exchanged)
- Delay in providing estimates (they are asking for immunity from 18 day rule, we are saying no)

I set out this week looking for the following 5 things
