thanks for reply; re the SGN position, I would clarify as follows; at SC 8 meeting yesterday SGN advised quite forcibly they had not signed up to an agreement, that they had met with TIE and after discussing at length, the retuned document to them from TIE, did not reflect the discussions and meeting agreements. They have written to TIE at high level and asked for a response within 10 days and 10 days after the deadline with no reply are now reviewing their escalation procedures, believing TIE are not fulfilling their part of the agreement to cooperate, and develop agreements and solutions.

I went to see Tony yesterday to express my concerns given the conflicting information being circulated, and again with almost no progress at SC8, and Tony advised he had sent a revised agreement to SGN yesterday and would send me a copy. Note this agreement has not been accepted by SGN as you were incorrectly advised

Re stray currents, all utilities consider this is becoming a serious issue, with unacceptable progress over the past few months and 90% of actions from SC7 meeting not addressed. Note BAA asked for a programme in February 08 and after detailed discussions yesterday TIE will now finally issue < 02/10/08. I would hope Graeme's feedback to the Infraco / Siemens team can move this critical isection of work forward
