This is obviously a very busy time and pressure to resolve issues with BSC have taken centre stage and, understanding the contractual and commercial issues with the scheme generally, we have been very patient in awaiting resolution of our MUDFA payments and our incentivisation payments.

During this time we have continued to support tie in the completion of the MUDFA works, as built etc. without any real explanation from tie of why PB has not been paid the outstanding balance for MUDFA works or the Incentivisation payments. We have also also had no response to our Applications for Payment 20 October relating to these issues.
