

At our meeting yesterday, we undertook to revert to you in relation to the information that it would be helpful for us to have in connection to claims by both parties under the Infraco Contract.

This forms part of the work that is being done to evaluate the automatic termination that would occur in terms of MOV4 if MOV5 is not entered into for reasons associated with funding.

As discussed, what we are looking for is a list of the claims that remain in dispute, with information in relation to:

- A brief description of the INTC, including value;
- Basis of dispute for example, Pricing Assumption No.1;
- Indication of status for example, "agreed in principle, dispute on quantum", or "dispute on principle";
- Whether the issue has been referred to DRP, and if so, the current position;
- Any other Infraco claims, not arising from INTCs;
- Any tie claims.

As you mentioned, we have information in relation to a number of specific items in dispute - such as INTC 536, or the adjudication on prelims. What we are looking for here is something which sets out all the matters in dispute, and categorises them in the way referred to above.
