1 PREVIOUS MINUTE 16 FEBRUARY 2012 AND **ACTIONS FROM PREVIOUS MEETING**

Sue Bruce welcomed Mark Turley to the Tram Briefing meetings.

Vic Emery advised that Alan Coyle was organising a working group to discuss the branding of the tram. This was a challenging issue and it was essential that any problems were resolved. Alan Coyle added that the group had been established but had not yet met. Lothian Buses had expressed dissatisfaction with the Edinburgh Trams logo but any changes at this point could result in significant additional costs. Dave Anderson observed that given the logo was imprinted on all the tram seats it would not be a good use of the public pound to alter it at this late stage.

Decision

- 1) To note the minute of the 16 February 2012 meeting and that it would be considered for approval at the 1 March 2012 meeting.
- 2) To request a branding strategy from Lothian Buses.

2 UPDATE ON JOINT PROJECT FORUM

Colin Smith explained that he had taken the Joint Project Forum through a threaded journey of previous

minutes to show the progress of the Project and the commitments made and acted on by all parties. Colin Smith noted that the notable achievement of the meeting was an endorsement by BBS and CAF to the investigation into the programme and the creation of an amended programme of Rev 5. This would be targeted for delivery by April 2012 and could mean that the end date of the Project may be examined to endeavour to bring it forward to December 2013.

If the completion date were brought forward, it should not be released to the public until greater certainty was achieved, so information could be released in increments as key milestones were achieved.

Vic Emery noted that it was positive that Dr Keysberg had highlighted that further cost engineering could be undertaken. Colin Smith agreed and added that work would be initiated further in this area.

Colin Smith advised that out of the 22 weeks saved from the cost engineering exercise, in his view a guide to that already "spent" would be 2-3 weeks for each area of conflict. The Scottish Water manholes issue would use an additional circa 2 weeks of time to date, however if not resolved this may take 10-15 weeks to re-design and catch up.

Vic Emery highlighted that the off-street issues were also important to resolve. BBS seemed to be concentrating on the on-street issues and giving less attention to the important issues off-street.

CS advised that we should look at the whole tram line issues as they would all affect the outturn programme and cost.

Decision

3 COMMUNICATIONS UPDATE

Neil Gibson highlighted that Councillor Gordon Mackenzie was keen to demonstrate how the Open for Business money allocated in the Council budget had been spent. Dave Anderson explained that this would be difficult as the West End Action Group was yet to meet to discuss how to spend the money. A meeting ITEM

would be held shortly. Dave Anderson added that the £100,000 had to be committed in this financial year but he did not believe it all had to be spent.

Bob McCafferty advised that earlier in the week a meeting for the residents of Baird Drive had taken place. These residents were very close to the tram works and there was a wish for some measures to be taken to alleviate the effect of the tram works. Sue Bruce enquired whether a screen could be erected between the works and their houses. In response, Colin Smith suggested buffalo fencing which was a product which had a 30 year lifespan.

Damien Henderson had not yet published his article related to subsidies for the tram. Neil Gibson observed that he believed that the article was going to be more political in nature and Damien Henderson was likely to want to speak to Councillor Gordon Mackenzie.

5 AOCB

Alan Coyle tabled an update on the Shandwick Place Information Centre highlighting the following:

- Planning permission was required to change the use of the premises. Planning had indicated this could take 8 weeks.
- The office space could accommodate 12 staff.
- Staff amenities would be provided in line with Council policy.
- The draft offer and lease was currently being reviewed by the landlord's solicitor.
- The customer service team and cleaning squad would be provided by SfC.
- The Communications Team would re-locate to the site.
- The branding/colour of the shop would be the same as the tram.

Mark Turley advised that a very experienced customer services staff member would be sent to the Information Centre. Alastair Maclean highlighted the need to ensure that the customer services staff were provided with the appropriate key messages.

Sue Bruce advised that in regard to the setts for the World Heritage Site there had been a number of variances looking to change the order after the decision had been taken. The latest variance had been the wish from the Planning Division to have recycled setts while the Roads section required new setts to be purchased. These variances did not reflect well on the Council. Colin Smith added that the new setts had already been ordered.

Mark Turley highlighted that work had been undertaken by the Roads Safety team on the affect of trams on road safety.

It was suggested that a tour of the tram route would be beneficial to members of the Tram Briefing meeting.

Colin Smith noted that the Department for Transport's security section had requested to visit the entire tram route. Colin Smith and Tom O'Brien would accompany them on the tour.

Colin Smith reported that the Scottish Water manhole impasse had been repaired with an agreed process solution; an all party meeting is to follow. The problem seemed to be that Turner & Townsend, BBS and SW

were talking at each other, rather than listening to agree a method to resolve the issue. Two weeks previously it had been agreed that Turner and Townsend would present a full picture of the situation to Scottish Water. Turner and Townsend did not pass all the information on to SW, contrary to that agreed at the control meeting. The impasse was opened up when Scottish Water became aware of the full extent of the situation. Work was still to be undertaken to complete the design solution for the manholes The project challenge would be to deliver the detail. CS organising "stay till it's finished" workshop 01.03.12.

Disappointment was expressed that Turner and Townsend could not resolve this issue without involvement from CEC. The consequences of the disagreement are significant.
