# Transport, Infrastructure and Environment Committee

Edinburgh, 29 July 2008

# 2 Prams on Buses – Motion by Councillor Mowat

The Convener ruled that the following item, notice of which had been given at the start of the meeting be considered a matter of urgency in order to allow the matter to be dealt with timeously.

The following motion by Councillor Mowat was submitted in terms of Standing Order 27:

'Committee agrees to call for a report to the next Committee on the legality and practicalities of carrying prams on buses.'

#### **Decision**

To approve the motion by Councillor Mowat.

# 3 Deputation

# Little France Cyclist Group (See item 4 below) – Cyclepath from Craigmillar to the New Royal Infirmary

Dr Forrester asked the Council to upgrade the Craigmillar Castle Cycle Path and extend the double yellow lines on Old Dalkeith Road. It was stated that there was a large number of people who regularly cycled to the New Royal Infirmary and an even larger group who would cycle if the routes were made safer. Additionally, this would contribute to a green and sustainable transport policy. The Cycle Path was currently not of sufficient quality and posed a serious problem for disabled people or parents with prams accessing the hospital. The alternative of cycling on Old Dalkeith Road was too dangerous for cyclists and the lack of paving meant it was unusable by pedestrians.

#### **Decision**

To note the points made by the Deputation.

# 4 Cycle Path from Craigmillar to the New Royal Infirmary – Motion by Councillor Ewan Aitken

The following motion by Councillor Ewan Aitken was submitted in terms of Standing Order 29:

"Council notes:

That the custom cycle path at Craigmillar down to the New Royal Infirmary of Edinburgh deteriorates significantly when it descends to the hospital, especially with its combination of poor quality gravel interspersed with 3-4 steps at a time with a concrete gully up the side of the steps.

That the path is similarly difficult to access for people with mobility problems or for those using prams.

That the biomedical park and the sick kids reprovision will potentially generate significantly higher usage for this route, especially with the implementation of green travel plans.

That this is one of the main cycle routes into a workplace housing two of the main employers of the capital city (NHS and University).

Council agrees -

To call for a report in two meetings time on how this investment in the cycle route could be achieved so it can be upgraded to a proper standard of accessibility."

Councillor Ewan Aitken was heard in regard to the motion.

### **Decision**

To agree the terms of the motion with the addition of the following to the final sentence:

"and also to investigate increasing the double yellow lines on Old Dalkeith Road."

# 5 Concordat Between the Council and Utilities Companies – Motion by Councillor Hinds

The following motion by Councillor Hinds was submitted in terms of Standing Order 29:

"This Council welcomes the signing of the Concordat between the City of Edinburgh Council and the utilities companies in 2007. The Council has concerns that roads and pavements are being dug up with little co-ordination between the Council and the utilities companies and are still taking longer on site than acceptable for traffic flow and pedestrian safety.

Therefore the Council asks for a report on how this Concordat is being delivered and monitored. The report should also address the possibility of an incentive and fining regime which would help co-ordinating and speed of works on roads and pavements in Edinburgh. Discussion should also be held with COSLA and the Scottish Government regarding this proposal."

Councillor Hinds was heard in regard to the motion.

#### Decision

1) This Council welcomes the signing of a Concordat between the City of Edinburgh Council and the utilities companies in 2007. The Council has concerns in some cases that roads and pavements are being dug up with little co-ordination between the Council and the utilities companies and still taking longer on site than acceptable for traffic flow and pedestrian safety.

- 2) The Council further notes that from Autumn this year new Scottish legislation will enable Councils to issue fixed penalty notices if the utilities should fail in certain duties in relation to their management of road works. The legislation also provides Councils with new powers to co-ordinate works, ensure the competency of the operatives, give direction to the timing of works and restrict the digging up of newly serviced roads.
- 3) That the Director of Services for Communities report to the September meeting of that Committee detailing the progress of the partnership agreement, and outlining how that combined with the new legislative powers, can improve the way road works are managed in the city.

  - undertake a detailed investigation of potential locations for bicycle share stations, taking into consideration streetscape and parking constraints, for the proposed Phase 1 area.
  - identify private sector partners to assist in delivering the project.
  - investigate the use of street advertisements to assist in funding the project.
- 3) That the Director of City Development report back on discussions with Transport Scotland.

Councillor Maginnis was heard in regard to the report.

#### **Decision**

- To note that the Ferry Road and Granton Road junction had been assessed for pedestrian crossing facilities and was ranked No 35 on the Pedestrian Facilities Priority List.
- 2) To note that the length of Ferry Road between West Ferryfield and Boswall Drive had been assessed for a signal controlled pedestrian crossing and was ranked No 18 on the Pedestrian Crossing Priority List.
- 3) To refer the report to the North Edinburgh Transport Group.
- 4) That the Director of City Development report on the criteria used to compile the ranked priority list and how local communities could feed into the process.
- 5) To note that the Director of City Development would look in the short term, at quick solutions, to improve pedestrian safety on Ferry Road.

# 10 Proposed Prohibition of Motor Vehicles, Meadow Place – TRO/06/131 – Motion by Councillor MacLaren and McInnes

The Director of City Development reported on the motion by Councillor MacLaren and McInnes on the closure of Meadow Place. The Director reported on the representations made on the proposals to prohibit motor vehicles

access, to and from Meadow Place at its junction with Melville Drive, and included accident statistics for Meadow Place and Melville Drive, the options for a new Traffic Safety Scheme for the local area and the current position and pedestrian/cyclist crossings and their potential requirement for further crossing places.

#### **Decision**

- To take forward proposals for low cost improvements at the Melville Drive/Marchmont Road junction in conjunction with the proposed works at Meadow Place.
- 2) To repel the objection and make the Traffic Regulation Order as advertised.

# 11 Lothian Buses – Bus Fares and Concessionary Travel Scheme – Motion by Councillor Henderson

The following motion by Councillor Henderson was submitted in terms of Standing Order 28:-

"Council notes the recent, above inflation, rise in Lothian Buses standard adult single £1 fare to £1.10 and that this rise is partially due to the Scottish Government's decision not to pass on Fuel Duty Rebate to Scottish bus operators in the same manner as happens in England."

The Competition Commission have now endorsed the fare rise and have acknowledged that it is attributable to Scottish Government policy.

Council also notes that the Scottish Government budget indicates that no further increases in fuel duty will be rebated over the next three years.

This will result in Scottish bus passengers paying a greater amount of tax on their fares compared to bus passengers in England and is likely to lead to fare increases in future.

Council also notes that the Scottish National Concessionary Travel Scheme is currently being reviewed and that the Scottish Government Budget provides insufficient funds to pay for the projected levels of demand from concessionary travel passengers. In addition, the introduction of concessionary travel for passengers receiving lower rate disability allowance will now be delayed. Council therefore agrees to request an all party deputation to meet with the

Minister for Transport and Climate Change to discuss these issues and make representations on behalf of the Council and Edinburgh's bus users."

To continue consideration of the motion to the Transport Infrastructure and Environment Committee of 5 August 2008.

# 12 Volume of Traffic on Restalrig Road South – Motion by Councillor Henderson

The following motion by Councillor Henderson was submitted in terms of Standing Order 28:

### "Committee notes:

The perception widely held in the local community that there has been a significant increase in traffic along Restalrig Road South over the last few years.

The lack of any pedestrian crossing along the entire road.

### Committee agrees:-

To conduct an assessment of traffic volumes at the crossroads with Lochend Avenue and Restalrig Crescent and at the junction with the roundabout at Sleigh Drive to see if a pedestrian crossing would be appropriate."

#### **Decision**

To continue the motion for a report by the Director of City Development.

# 13 Review of Packaging Recycling Service – Motion by Councillor Child

The Director of Services for Communities reported on a motion by Councillor Child on ways of improving the servicing of packaging recycling bins on street and in supermarket car parks. The Director outlined the short-term actions proposed to enhance service operation needed to relieve the pressures on the Packaging Recycling Service.

#### **Decision**

1) To note the report and in particular the short-term measures being taken to enhance the current service.

- 3) To note that a further report on the Recycling Strategy would be submitted to the Committee in September 2008.

# 14 Residential Parking Permits – Proposed Alterations to Charging Mechanisms Linked to Environmental Concerns – Motion by Councillor Burgess

In response to a motion submitted by Councillor Burgess, the Director of City Development sought approval to implement a charging structure for residents permits based on the carbon dioxide emissions or engine size of a vehicle and to increase the charge for a second permit.

#### **Decision**

- 1) To continue the report for further consultation and:
  - i) To examine in detail the effect of the UK Government's massive increase in certain road fund licence fees.
  - ii) To ensure that the effects of any anticipated changes were revenue neutral to the Council's budget position.
  - iii) To further examine upon which criteria charges should be based.
- 2) That the consultation period last for a period of three months and include Neighbourhood Partnerships and Community Councils.
- 3) The Draft Consultation be circulated to all political groups' transport spokespersons.

The Director of Services for Communities gave details of how a green concordat with retailers in Edinburgh could be implemented, as part of an Edinburgh Business Environment Award Scheme, and highlighted ways in which the Council could support the reduction in use of plastic shopping bags.

#### **Decision**

- To approve the development of an ongoing lobbying strategy in partnership with COSLA.
- 2) To approve the introduction of the issue of the single use plastic bag as a campaign theme within the overall Waste Aware Edinburgh campaign programme.
- 3) To approve the creation of a specific award, as part of the wider Keep Edinburgh Clean Business awards, to recognise those businesses and organisations that could demonstrate a reduction in the use of plastic bags.
- 4) To approve the development of a series of appropriate consultation activities with relevant organisations such as Edinburgh Chamber of Commerce to discuss and develop the implementation of a voluntary code of practice for the reduction of single use plastic bags.
- 5) To approve the continuation of the Waste Action Grants programme to provide direct support to local communities to support waste diversion initiatives such as the production and sale of re-use bags by local retailers.
- 6) To approve further consideration of the introduction of a charge for plastic bags issued on Council premises, and that a report be put forward as appropriate, following consultation with relevant stakeholders.

- 9) To change the name of the scheme to the 'Healthcare Workers' Parking Permit Scheme.
- 10) To ask that a progress report be submitted to the meeting of 25 November 2008.

- 3) To note the intention to enter into discussions with the residents of all existing developments and roads affected by the proposals contained within the report by the Director of City Development, on how these areas would be managed.
- 4) To note that the owners of privately maintained roads may choose for their roads not to be controlled by the Roads Authority but that in doing so they would accept that no form of control could be enacted by any other party.
