We have reviewed the CEC Application for Payment No1 for £11,618,217

As this is the first application, we do not intend that it should hold back payment for lack of detail and you should proceed to invoice Transport Scotland for the full amount shown above.

However we do have the following comments, mostly about the lack of appropriate detail for the expenditure incurred and it is important that you accept Transport Scotland's need for more clarity in the numbers going forward especially as the forecasts keeps falling and the need to maintain accurate accruals. If you recall I mentioned this our Wk2 meeting yesterday.

For example, the £11m application is broken down into 8 summary headings with the main costs relating to Advances Works £2.060m, Utilities £4.634m, Design £2.538m and Project Management £1.194m. There is no additional detail below these summary heading in order to investigate the valuation further, going forward we need more detail from CEC. We are aware of the general nature / rationale for this expenditure

but it is important that this is related directly in the body of the application. We may also wish to see further supporting documentation but meantime let's start with the above.

Other points to note are;

a) the "Management Tool" spreadsheet (as previously discussed and agreed ) is needed each period to show the detail behind the summary figures and ultimately this Mgt Tool will be used to compare application valuations against progress i.e. Cost of Work Done (COWD) and to monitor spend and valuations against each cost heading.

b) In order to reconcile previously billed amounts between CEC and the TS Finance Ledger, can a transaction report be provided by CEC before the next application, which breaks down the £82,254,589 Previous Cumulative Application into individual invoice transactions.

Please feel free to come back to us on the above and consider a meeting to finalise agreement on our requirements. Please ensure that Stephen Smart is included in any further discussions and that my TS Finance colleague, Clair Cameron also receives a copy of the invoice.
