We have reviewed these documents and do not have any major issues on the tramco procurement alone. We do have concerns about the infraco procurement and the potential novation of tramco to infraco – and what happens if novation is not possible. Damian Sharp may have commented separately.

I understand from Mark Gardner that your own internal timetable has been extended by a week, to the end of next week. It seems to me that for an additional delay of a couple of days we could discuss the overall procurement strategy on Monday 10 July at the agreed meeting. If that goes successfully, and if Transport Scotland agree, you would be able to release the tramco documents immediately afterwards.
