Further to our discussions on this subject, I am happy to discuss the content of the attached slides with you and Rebecca to further understanding but strongly believe this must not be shared in this detail in the council report for the reasons we discussed on Friday.

In any event the items can only be closed once the risk events have been confirmed as concluded (and many of those apply at actual contract close not in advance) and I believe this level of detail in your report to council is not appropriate and counter productive in commercial negotiations with BBS.
