Thanks. Frances has agreed to have a look at the grant conditions as well as Bill.

The IDM meeting of 16 May decided to support the current funding application as set out in the text of the grant offer. The approval I am seeking is that the conditions accurately reflect the IDM discussion.

There is no clawback provision in the current grant offer. That was discussed and is compatible with our funding of other schemes.

The clawback/termination costs provision that would need to be considered is in the next grant offer (due early 2007) when we should include a provision that if a new Council wished to cancel the scheme post elections then they would be liable at least for termination costs. This is to cover the rhetoric from some candidates that they would cancel the tram if part of the ruling group on the Council after May 2007.
