#### Dear Steven

It has been brought to our attention that Tie is looking to engage multiple contractors working on multiple sites to complete the outstanding diversionary works as part of the initial MUDFA scope. This has already started to cause concern in respect of competency requirements and adherence to SGN processes for the Safe Control of Operations (SCO) activities.

Up until this point Michael Blake has been the single point contact and this has generally worked well. Michael knows the SGN requirements and has gas engineering background. It would now appear that Tie propose to use multiple contacts none of whom have any obvious gas engineering background or understanding of what is required to safely undertaken gas operations.

In particular, we are concerned that Blyth Contractors are intending undertaking works on a live gas asset in Princess Street without sufficient understanding of the process required to work on such mains. This is despite numerous advance notifications from SGN on this issue.

We are also concerned at the proposed timescales for gas diversion works at Lindsay Road Edinburgh. To date, we have not received or agreed a design or financial contribution for this section from Tie, however the Contractor is advising that they are to start works imminently on diverting the gas assets.

The above items are clearly a cause for concern to SGN and I should appreciate if you would review this issue and revert back to me with Tie's proposals going forward.
