I'm just looking at the figures Bob and Campbell have compiled for the table at section 2.5 of Sch 4 – see attached file *The Contract Price.xls*. I need to confirm or clarify some things with you. Thanks for you help.

• The figures provided for Infraco Maintenance Mobilisation and Spare Parts are :

Infraco Maintenance Mobilisation:
 Infraco Spare Parts:
 £1,782,291 (compared to £1,397,000 provided in the budget)
 £1,223,332 (compared to £1,174,762 provided in the budget)

Can you help me by confirming that the updated figures are correct; will be recognised by BBS and also point to the specific page in the schedules where I can find them? Please can you also provide an explanation as to why they are higher than the budget provisions by £434k?

- We have taken the £300k VE item on rationalising spare parts (Appx. C Item 25) as a credit against the Construction Works Price but that does not appear to me to be an issue so long as we get credit somewhere.
- Infraco depot equipment has been identified as separate £2.5m line item (line d) over and above the Construction Works Price. I'm pretty sure this is wrong as the CWP already of £236m already includes for all dept equipment being supplied by Infraco but can you confirm anyway. I'm also going to delete line f for the Tram model as that was not supplied under the Infraco or Tramco contracts.
- The Tram Maintenance Price over 30yrs is a calculation based upon assumptions about km in service, indexation for inflation and an exchange rate, all of which will be subject to change. Do you need to agree the assumptions used with the BBS people and then spell the assumptions out here?
- Do we actually need lines for demobilisation cost for the Maintenance sections?

- The table has separate lines for the "SDS Price" and the "Tram Supply Price". Do we know when the "SDS Price" will be available to slot in here.
- We have an anomaly here in that the SDS Price is already included as a "provisional sum" at £2m in the Construction Works Price of £236m but is <u>not</u> actually listed as a provisional sum in Appx B of Sch 4. **Please can you confirm that we are not running into any problems with this one?** My view as expressed before is that we should remove the £2m "provisional sum" from the Construction Works Price.
- What are the implications of the total for Construction Works Price and Contract Price (including revenue items) anyway i.e. is there an imperative to make the CWP higher or lower?
- Is the overall presentation of the table what you expected to see?
