


I am apprehensive about reporting on some position which are in fact not closed but that is where the project sits tonight. Some of CEC requirements I do not fully understand in terms of selected interest - liability caps would seem to me more interesting than Conditions Precedent or authority to sign, but there we are.

The DLA report and Risk Matrix are on the stocks but will come out tomorrow morning at some point once I get a window from negotiations to have a look at product overnight.
