David / Tony,

I have completed my overview review of the SDS Design Programme V14 received 26th April 2007 with a data date of 9th April 2007.

I have reviewed only to sub-section level and not line by line.

We should ask SDS to provide a commentry on the reasons for the movement in dates since the agreed V9 Baseline issue in mid December 2006.

John McAloon has also prepared a report which shows movement activity by activity (see attached).

The attached spreadsheet shows the movement in number of days by phase (PD or DD) and sub-section since the agreed baseline issue V9. Positive numbers/red blocks indicate finish date has slipped and negative numbers/green blocks indicate finish date has come forward.

- There are eight areas where the PD is not complete and the completion date has slipped from the V9
 Baseline issue.
- There are eight areas where PD is not complete and the completion date has slipped since previous issue V13.
- There are fifty-one areas where the DD completion date has slipped from the V9 Baseline issue.
- There are forty areas where DD completion date has slipped since previous issues V13.
- There are 2 ares where the DD completion date has improved since the last issue V13
- There is 1 area where the DD completion date has improved since the V9 Baseline issue.
- The total planned man-hours have increased by 1081hrs
- There are sixteen areas where the slippage in completion of Detailed Design (V14) is greater than the 28 days elapsed since the last update (V13). The worst being
 - Caroline Park to Granton Square Intermediate Section Wide 145 days
 - Crewe Toll to Caroline Park Intermediate Section Wide 111days
 - Roseburn Junction to Haymarket Intermediate Section Wide 90 days
 - Haymarket to Princes Street West Intermediate Section Wide 82 days
 - Gogar to Airport Intermediate Section Wide 82 days
 - MacDonald Road to Foot of the Walk Intermediate Section Wide 72 days
 - Edinburgh Park Gyle 67 days
 - Edinburgh Park to Gogar Intermediate Section Wide 65 days
 - Saughton Road North to South Gyle Access 61 days
 - Foot of the Walk to Newhaven Road Intermediate Section Wide 54 days
 - Princes Street West to MacDonald Road Intermediate Section Wide 49 days
