James,

As you are aware I was out of the office yesterday so you may have covered this in the conference call which I noted was set up yesterday. However, just to be crystal clear on this - the offer of assistance from Anne Walton is much appreciated, however it needs to be on the understanding that Anne can amend the relevant elements of the programme, such as rationalising activities and removing activities which are duplicated. If the intention is just for Anne to come and sit with me and just plug in info to the TCR sheet that I tell her while sat next to her, then that will be of no benefit whatsoever and will not resolve the problem. Can you please clarify on what basis Anne's involvement will be?

In addition, I was considering this problem yesterday and wondered if I could propose an idea? One of the issues I have observed with the programme team in Edinburgh is that almost as soon as they complete the programme update, they are virtually straight onto the next round of sending out TCR's and updating, therefore there does not appear to be any time for "maintenance" of the programme. Is there any mileage in discussing with tie the possibility of "missing" the next update in order to free up some time for doing some work on the programme as I note above, eg rationalising and removing activities across all disciplines where the TCR return/programme size is an issue? Perhaps this could be proposed to tie on the basis that doing this would benefit them and assist them also in reviewing the programme? This is just a suggestion, and I am aware that given the recent elections in Scotland there may be other considerations which impact on this.

Jason,

The job is not suffering because we are not doing TCR returns and to suggest so is laughable. As you point out we need to win new work and need to deploy our resources accordingly, and at times, priorities need to be made. I fail to see how not doing an administrative procedure jeapordises our relationship with tie - those problems run much deeper than that. On the structures as an example, we are now at hold points in our design due to awaiting information and decisions, both internal and external - it is this kind of issue which is stopping us delivering on Edinburgh Tram and not compliance with an internal administrative procedure which on this project has been set up extremely poorly.

To point out a couple of things in your email, in one of our many previous discussions I did say that we could radically reduce the number of activities in the structures programme without prejudicing the programme and which would at least give us a sporting chance of getting meaningful information back to you in the short timescales provided. No action was taken by the Project team in Edinburgh to address this.

As you note, in your last paragraph, this is the fundamental weakness in this process - it relies on the DTL's intimate knowledge of a job to update the plan and the cost to complete, and throwing resource after resource at this will make absolutely no difference. I welcome your comment that you will assist where possible, but as I have noted above, no action has been taken previously, so I am sure you can forgive my scepticism on this.

I agree we should talk, and as always, will do my utmost to assist.
