Jim,

This is my report for Monday afternoon,

Walter McQueen from Scott Wilson will lead a programme which has the following elements:

- 1. A systematic review, structure by structure along the route, to determine the answers to the following:
- Is the structure over-designed (according to the bidders)? If so, how much can be saved by right-sizing?
- Is there a cheaper construction (steel for concrete)? And if so, how much of a saving is there taking into account such whole-life costs as additional maintenance?
- Is there an option to draw back from features added subsequent to PD1 to improve the 'aesthetics', and if so how much of a saving will there be?
- A schedule summarising the above and specifying, structure by structure, the likelihood in terms of engineering deliverability of achieving the identified savings.

Important points to note are:

- This programme of work must be completed by 28 August (preferably earlier) and the work programme and scope shaped to deliver confidently within this timeframe. This programme must be run as a separately identified workstream in order to focus effort. The outcome of this work is pivotally important.
- I expect that the review will make maximum use of the work already done by SDS which has covered a
 number of these features and in which they have significant expertise. Bruce Ennion is the SDS point of
 contact and he and I have already met Walter McQueen to initiate this work.
- An early estimate of likely savings to be identified is also important pending more detailed work to support the savings robustly.
- An important element of the programme will be stakeholder buy-in and Ian Spence from CEC must be involved amongst other stakeholders (Edinburgh Park). Lindsay Murphy will act as a point of contact to effect this.
- A weekly 'flash report' specifying progress and issued on Fridays is a requirement.
- Walter McQueen will attend the meeting on Mondays chaired by Jim McEwan which monitors progress on this and other VE work (and will bring the flash report with him). Bruce Ennion will attend on Monday 16 July 2007.

A first cut statement for item 2 above by Friday 27 July 2007. Other deliverables are dependent on the content of this report.
