Gents.

Following my meeting with Jim Cahill this morning the matters arising are:

- We applied for £2,729,364.10 and he will be certifying £1,675,326.00
- Main Issues
  - Claim £500,000 will not be paid until they have received signed agreement
  - ETN Phasing total deducted should be £800,000 we have deducted £627,500 a difference in this application of £172.500
  - Citypoint Rental Contribution: he will deduct £8,565 per month until the Novation is signed. Total difference between applied and certified is £28,771
  - Amount claimed but no official submission to tie £50,743 (CRT's 080, 111 and 149). I'll be getting these across ASAP.
  - Items included in Settlement £63,091
  - Meeting Room Hire £17,718 will be paid if we provide copies of the invoices. I will be arranging these.
  - Jim Cahill has deducted £75.531 as he is awaiting SDS to provide substantiation. I will be looking into those
  - The disputed items amount to £24,590 which I will be reviewing.
  - Items paid up to agreed value means an adjustment of £59,777
  - Adjustment made on MUDFA (CRT219) £49,023
- Amount of Changes: Jim Cahill intimated that there is a concern that the 'printing presses' will start churning out changes.
   I confirmed to him that we are doing an exercise so that there will be no surprises for either party.
