Please find attached the marked up draft of the design/construction programme tracker as discussed earlier.

I have added the SDS comments to supplement those previously added by Tom. I have also added additional structures where special measures have been taken by SDS to achieve construction programme dates.

It must be noted that in order for SDS to achieve these IFC dates requires other third parties also to accept reduced timescales for approval and consent and generally to adopt the assumptions made in deriving the new dates. CEC in particular will need to agree to the changes proposed.

In order for SDS to include these amendments in the next update of the plan we will require tie to accept that the risk of making these amendments is not SDS contractual responsibility and we would appreciate and instruction to amend our programme in line with these assumptions.

Could you please forward the tie master programme as discussed earlier, to allow me to assess the impact of these changes on the overall project.
