#### 2 Client Relations

# 2.1 Meeting with PB & TIE - Tuesday

Matthew Crosse, Geoff Gilbert, Greg Ayres, and I met on Tuesday to discuss the recovery of additional costs arising from prolongation of the programme and to review progress on the resolution of outstanding change requests. As already reported, PB put forward indicative sums for costs incurred. PB also provided sample documentation summarising the reasons for delay, notably due to the Charrette process conducted by the City of Edinburgh Council following submission of the Preliminary Design at the end of June last year. Matthew is now considering TIE's position. PB is compiling full documentation in support of the claim and is also working on the remaining action agreed with Matthew a week ago to quantify the remaining cost to completion of the contract. The action previously reported for PB to consider the options for a new commercial framework is continuing.

# 2.2 Tram Project Board Preparation

Day-to-day client relations have focused on preparation for the next Tram Board scheduled for 17 May. Matthew's summary of papers required is presented here to give an indication of current priorities from TIE's perspective

#### 3 Contract

Watson Burton continues to provide expert guidance on the structure and presentation of the claim for additional costs arising form the prolongation of the programme. Watson Burton is currently engaged in reviewing the wording of the documentation prepared by PB. Chris Atkins has been tasked with preparing an Executive Summary covering the narrative and quantification of the case. Completion of the final document will be no later than Monday 14 May.

#### 5 Critical Issues

The fourth special meeting to action clearance of the remaining Critical Issues was held on Thursday. Table 1 shows performance achieved in clearing the high, medium, and low design impact Issues since w/c 19 Feb. Table 2 shows current status by Section. The continuing problem of clearance of 10 high impact items is the salient point to note from this analysis, with TIE recognising the importance of addressing these issues if the revised master programme is to be maintained.

#### 6 Finance

### 6.1 Engineering Review of SDS Proposed Changes Meeting

The first of these meetings, it has now been agreed, will be held next Tuesday. The topic will be included as an agenda item on the two weekly Project Management meeting chaired by Tony Glazebrook. Some twenty SDS change requests are queued awaiting consideration at this engineering review prior to submission of any accepted items for TIE commercial processing to formal change notice status.

### 6.2 Financial Review of Historic Changes Meeting

No meeting this week due to Geoff Gilbert being away on a TIE Management Course with the others on the TIE Senior Team. The next meeting is scheduled for next Friday. In the interim we have been working to clean up the historic change records such that the information required to filter the register is all available next week.

### 7 Operations

Date 04 May 2007

I have been working closely with David Crawley to define the schedule of deliverables to completion of the contract and to give David the data he requires to populate the "dashboard" presentation requested by Matthew for communication to the Tram Project Board. It is intended that this means of presentation will facilitate a more objective assessment of PB /SDS performance than has been the norm. From PB's point of view, a periodic review of actual performance vs planned achievement of milestones will provide the firm foundation to demonstrate the quality of the operation and will also serve as the reference point against which to flag up the consequences of failures by others to provide information necessary for the SDS contract to progress. Table 3 provides the first chart in the agreed format which shows the actual rate of progress to date and the planned forecast to completion for the 5,800 milestones defined by the P3 programme.

#### 8 Other Issues

The performance of the MUDFA contract is causing concern within TIE and pressure is currently being applied to SDS to ensure effective interaction between the two contracts. It would appear that criticism of SDS quality can easily be refuted, but problems are being experienced due to the Statutory Utility Companies, (SUCs), not being able to meet the review periods previously agreed, (with all parties including TIE), on the master programme. This is delaying the production of deliverables by SDS which are required by MUDFA to progress the utilities diversion works. We are currently working closely with MUDFA and the SUCs to ensure the release of sufficient information to allow work on the ground to proceed, thereby avoiding claims for delay by MUDFA.

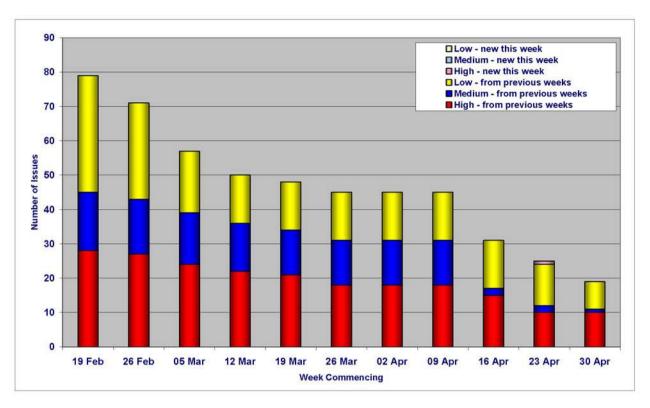


Table 1 Critical Issues Clearance Progress

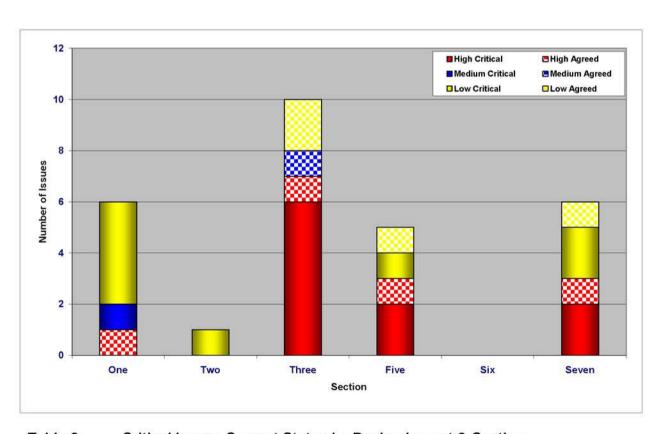


Table 2 Critical Issues Current Status by Design Impact & Section

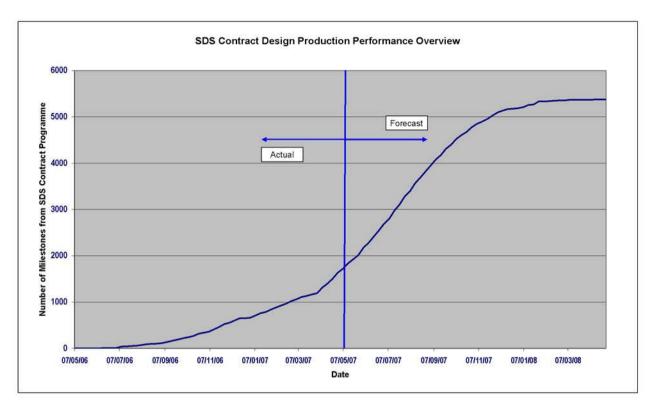


Table 3 Schedule of SDS Deliverables
