Keith, these items went through project document control today as a result of yesterday's meeting, and my calls with Halcrow's senior guy, Dave Watters today. A fourth note confirming our requirement that tie respond to the June 1 claim by next Wednesday will be sent first thing tomorrow. Steve has done a great job in turning these around from yesterday.

The letter to Halcrow, penned by Steve, transmitted a letter from tie's Utilities manager who attended yesterday's meeting with Matthew. The utilities issue is now very much on the front burner, and took up an hour of yesterday's time. Tie's position is that Halcrow re falling at the first hurdle prior to the start of utility diversion work 9 July. There is a significant number of deliverables due tomorrow which will not hit the deadline to enable work commencing August 20. Last weeks drop had some quality issues, and are being resubmitted by Halcrow. There seems (to me) that there is some ambiguity regarding the interface and responsibility matrix between SDS/Halcrow, the SUC's, MUDFA and tie. I have asked Steve to respond and he has undertaken to clarify this work flow, and the level of detail in PB's technical output (i.e. not bills of quantity as suggested by tie in yesterday's meeting) and impose a recovery plan on Halcrow.
