Colleagues, here is the most up to date tie business plan for FY06. The changes from the December submission are highlighted and a spreadsheet setting out the changes to the detailed numbers is attached. A separate mail has been sent responding to detailed CEC questions on the December draft but the key responses are also incorporated as appropriate into the attached draft plan. With respect to the tram implementation team, the rationale for the costs is now explained in the plan and Michael has sent detailed confidential support to Andrew Holmes, including the FWB benchmark study. We have also now included an analysis of this spend by manager.

The document is as final as tie can deliver at this stage. The areas I would draw your attention to are :

1. The assumption that CC funding will be 50/50 between the Council and the Executive, although (so far as we are aware) this has not yet been agreed. If there are any changes to this assumption, including possible clawback of Executive funding from actual scheme revenues, these will need to be reflected in the plan (or at least the Council paper) which is put before the Council for approval on 24/2.

2. There are unquantified references to a CEC contribution to tram project implementation funding and also to dependence on future dialogue for approval to access Executive money. The OBC will catalyse this process but there is a need to have reasonably early agreement on certain spending streams (especially people). I=92m assuming the Council can approve the plan subject to the resolution of these funding arrangements with the Executive.=20

3. So far as I am aware, neither tie nor CEC has had formal confirmation from the Executive of the proposed aggregation of the Tram lines 1 and 2 development budgets for the current year.=20

=20

4. A number of matters will require continuing dialogue after the Council have seen the plan on 24 February. These relate mainly to the implications of the referendum and to the deferral of funding decisions on the tram project for next year pending review of the OBC in the Spring. These matters are listed in the Executive Summary of the plan.
