Thank you for the feedback following your recent meeting with Cllr Balfour and Cllr Jackson.

I'm naturally pleased that they seemed to have adopted a more positive stance; however I have to confess to being deeply troubled by what I thought had been agreed as a TEL Board decision once again has been referred to the full Council for approval.

I have no doubt whatsoever that the TEL Board (with the exception of Cllr Jackson who probably reserved his position) would unanimously support the senior appointments effective from 1 October. However there seems little point of once again going over and over considerable old ground. I will therefore have to explain as positively and tactfully as I can to the key people involved and continue to do everything I can to keep them on side.

Nevertheless it would be irresponsible of me not to caution that we are falling further and further behind where we should be on Integration etc and inevitably there are growing inefficiencies and other detrimental factors which cause me real concern.

I had a constructive discussion with Councillors Balfour and Jackson yesterday about the leadership and senior management issues which need to be resolved to allow the next stage in the integration of tie/TEL and Lothian Buses to be taken forward. I think they now have a better understanding of what is required and will try to be supportive.

Timing is the key for them. They need to know that we have a viable way forward on the tram project. This, in turn, unlocks the implementation of the senior management appointments.
