Following input from Steven, Tony and Graeme, here is the revised proposed DLA Piper letter to BSC.

1. I have attempted to trim this back in the "here are the facts" section (**pace** Tony); at present, we have not replied to the accusations made in the first three bullets - utilities not complete until Nov 2010, 90 weeks late; all on street sections subject to change; much of the off street sections are too. On reflection, I consider if there was one line against each, it would add force if **tie** concedes a truthful point as opposed to silence. **Steven, Tony?**
2. I have removed the specific DA reference
3. I have included the 18th Feb letter from **tie** to BSC on defamation; we still need the dates for the programme rejections and the two recent Haymarket letters
4. I have stuck with a seven day reply period; I am not wedded to this but longer gives the appearance that **tie** are not that bothered (Tony, I think favours a longer time).

Await instructions on these refinements. I have in the meantime sent this version through to Alastair Maclean.
