All, please refer to the attached position paper regarding MUDFA's position relating to the 'as-built'. It would appear to me that SDS are once again attempting to obtain additional monies for what is in essence their obligation under the contract. Note their comments with regard to relevant documentation, which needs to be addressed. However, do not accept that this would involve SDS being entitled to additional funding, as this is something they should be providing under the contract. The matter pertaining to L&M and their implementation was initially a 'stop gap' to avoid unnecessary delay to the issue of as built drawings for Infracore, not MUDFA seceding to the issue surrounding obligations.

Dennis did we issue this out to them? We need to discuss this matter, it is not getting any better and we are incurring considerable costs with the engagement of L&M, whilst this issue persists.
