For clarity, BSC's position on Roseburn VE design is as follows :-

We have submitted what we believe to be a contractually clear position that the conditions precedent to your instruction to implement Roseburn VE have not been met. There is therefore no obligation on BSC to deliver the revised design at the VE price saving identified in Schedule 4. Tie have so far failed to respond to the detail of our submission in this respect, simply reiterating your instruction to proceed. This unresolved issue is one of many that need to be closed out as part of the ongoing management review currently in progress and which may be discussed at the meeting of principals on 9/2/09.

We appreciate that the form of structure shown in the selected Value Engineering option complies with the third party requirements and therefore, in practical terms, is what needs to be built. There have been discussions at management level (Bell/Walker) about possible compromise solutions to resolve the dispute over VE savings.

To realise any mutual advantage in a compromise solution, it is important that the alternative design be progressed such that construction in accordance with the revised programme remains feasible. We have therefore confirmed to SDS that they should proceed with the design, at our cost risk, in the meantime. If no progress is made on resolving the open issues, we would review whether to allow SDS to continue design works.

I am happy for Stefan to provide the design programme information that you are requesting, but please keep in mind the background to the situation, as described above.
