Joachim / Stefan,

I met with Richard and Michael prior to the Tram Project Board at 3.30pm today. Richard formally communicated that BB require an additional £12m to conclude the deal. The rationale was sketchy, but he accepts that he should have communicated this factor before our meeting with you in Edinburgh on 14th of April. The Tram Project Board are astounded that this price change has been proposed within a few hours of Contract Closure. Moreover, the behaviour is not consistent with the rules of procurement under which BBS were selected as preferred bidder, and is not a good example of how partners should behave.

I believe Joachim is available to meet in Edinburgh on Monday. We would like the meeting to proceed, however, we wish no further involvement from Richard. Our Project has lost confidence in his Leadership of the Consortium – this is unfortunate but I am sure you can understand our frustration.

A deal has been negotiated and was agreed on April 14th by all parties. We are happy to proceed on that basis. I cannot seriously recommend continuation with BBS unless we can get back to the proposition that has been agreed with Transport Scotland & City of Edinburgh Council and now been externally communicated to the general public of Scotland.
