Please find an updated copy of the EAL Schedule (clean and dv) which includes revised drafting in relation to the Emergency Procedures Protocol. I have also included drafting in relation to compliance with new title conditions which will be treated as a Mandatory tie Change.

Please note that the Infraco Contract has been adjusted as follows:

- Drawdown Notices, the EAL Lease and EAL Licence are included within the definition of "Land Consents"
- EAL Permissions and EAL Works Data have been included within the definition of "Design Stage Consents"
- The order of precedence has been adjusted in respect of any conflict between the Agreement and the EAL Schedule (on the basis that there are conflicting obligations in the EAL Schedule - e.g. site security)
- Fossils - refers to EAL Artefacts
- Collateral Warranty - there is now a reference to the EAL form of warranty in Clause 74 - please note that Brodies have not commented on the proposed amendments to the collateral warranty
- We have included "EAL Works" within the definition of "Infraco Works"
