Please find attached the ER's which reflect a consolidated version with the following additions:

- 1) All of the legal alignment changes agreed on Tuesday, including sections 23 and 40.
- 2) The technical adjustments that were made by yourself and Andy Steel on Wednesday.
- 3) The CEC changes that resulted from their review, which are separately appended for your quick review.
- 4) Revised section 26 Track. This has been updated to reflect the SDS final design data and means that the contents of this section will be consistent with their design. I am still waiting for confirmation from CAF that these very minor changes do not impact their DKE compliancy statement. I will separately copy you in on the email.

Still to be finalised are sections 8, 13 and 17. You will recall Sharon Fitzgerald (DLA) was going to carry out a legal detail alignment check. We expect these first thing on Monday AM.

We also note that Angus Mackay from Biggart Baillie has yet to confirm his acceptance of sections 23 and 40 (my understanding is that he is separately seeking approval from Siemens). He has also requested sight of the entire document to cross check the changes we agreed on Tuesday.

We will not commence the final cross-referencing check detailed in Matthews email earlier any further changes until you have confirmed your acceptance. The changes that Sharon has to complete will be separately sent and consolidated early next week.

We are still checking 28.13 for technical consistency.

Any other remaining []'s will be picked up when we do the cross-referencing.
