EDINBURGH TRAM NETWORK

This letter is to confirm the continuation (until further written notice) of our mandate for TEL Limited to provide legal advice in connection with aspects of TEL Limited's involvement in the Edinburgh Tram Network (the "ETN").

Our appointment shall be subject to the same terms and conditions upon which we are engaged by tie Limited for the ETN. Under those terms and conditions, the rates for our services are subject to annual review on the basis of applicable public sector comparators. We shall invoice tie Limited monthly in arrears as has been our existing practice.

With regard to our duty of care, we shall owe no greater or different duty of care to TEL Limited's owner, City of Edinburgh Council ("CEC"), to that duty we owe to TEL Limited itself. Unless explicitly instructed in writing by TEL Limited otherwise, we shall be entitled at all times and without inquiry to rely upon instructions from TEL Limited and its officers as aligned with CEC's overall policy, but interests and commercial objectives for the ETN and as if those instructions emanated from CEC. The above accords with our arrangement with tie Limited. Our instructions shall be given by yourself, Willie Gallagher or Neil Renilson.

I confirm that at present I do not see any legal conflict of interest to prevent or hinder DLA Piper representing tie Limited and TEL Limited on the basis that under authorisation from CEC the two CEC subsidiaries' business objectives and interests are aligned for the project delivery, integration, operation and maintenance of the ETN. Additionally, we are under a specific duty to avert legal conflicts and to alert tie Limited and TEL Limited to any which may or do arise during the provision of our services. There may nevertheless be issues which arise concerning TEL Board directors' individual positions at law on which you would require separate advice.
