Further to my conversation with Jeff yesterday, I have listed the tasks which we need to carry out for the SDS procurement and the RSC procurement. I have also set out a few thoughts for further consideration.

- 1. Amendments require to be made to the Revenue Setting Committee OJEU and MOI//PQQ (e.g. we will need to refer to the inter-relationship with SDS, joint and several liability etc.)
- 2. SDS ITT we need couple of background paragraphs on scope, relationship with RSC etc. Also, we need to describe the tender deliverables which each bidder will need to produce as part of the tender submission e.g. modelling methodology, costs (I have spoken to GH who is aware of the need for SDS to price this into the tender) etc.
- 3. SDS Contract we need a "contractual" scope of services. Jeff mentioned that this may be fairly short and simple.
- 4. We need to discuss the following issues with IK:
 - contractual form
 - impact of novation to infraco
 - necessity for side agreement between RSC and SDS to off-set joint and several liability
 - Novation/TEL
 - Could SDS do it all? pre-novation? or are different skill sets required?
 - What about inputs to the model post base preparation? tie pay twice?
 - More expensive because of joint and several liability?

- Acceptability to the market of of joint and several liability in the contracts.
- Conflict issues of modellers bidding for SDS and RSC.
- Issues raised in Jeff's e-mail on cherry-picking who does what in the development process to be discussed.
- 5. We need a tie technical team member to confirm that highway design and the use of the model is adequately covered off in the scope of services for the SDS Provider.

I am conscious that Jeff's time is limited and we were hoping to catch up with Ian and/or Jeff at some point today.

Ian - Please let me know when would be suitable.
