1 Deputation Request

A request for a deputation in respect of item 3 on the agenda, the minute of the Transport, Infrastructure and Environment Committee of 23 November 2010 had been received by the Moray Feu Residents' Association.

Decision

2 Minute of the Transport, Infrastructure and Environment Committee of 23 November 2010

Decision

The Committee agreed that a paragraph be added to reflect the Order of Business at the meeting as follows:

- i) The Convener ruled in terms of Standing Order 16 that the Order of Business for the meeting be as shown on the agenda and that the deputations be taken prior to the items they had requested to speak to.
- ii) To otherwise approve the minute of the Transport, Infrastructure and Environment Committee of 23 November 2010 as a correct record.

3 Edinburgh Tram – Shandwick Place and West End Junction Review

At its meeting on 23 November 2010, the Director of City Development was instructed to report on the options to improve vehicular access to Shandwick Place until the Main tram works recommence and to review the east to west pedestrian crossing timings at the Princes Street/Lothian Road junction.

Details were provided on options to improve vehicular access to Shandwick Place in particular the re-opening of the west turn from Lothian Road into Shandwick Place.

Decision

- To note that vehicular access improvements to Shandwick Place had been investigated and a number of temporary improvements would be made.
- To note that these would be monitored and further improvements made if required.
- Note that a report on air quality issues would be presented to a future Tram Sub-Committee.

4 Duddingston Village – Traffic (Motion by Councillor Ewan Aitken)

(a) Deputation

Lindsay Crofts, on behalf of Duddingston Village Conservation Society, advised that they had had a meeting with Council officials, the police and Historic Scotland on 8 February 2011 and had hoped that the conclusions from that meeting would have been fed-in to the report by the Directors of City Development and Services for Communities. The report did not readily identify the problem of the strategic movement of traffic between

the east and the centre and southern parts of the city. The consultant's report commissioned by the Conservation Society showed that the narrow residential road was well over capacity, that it was being used as a quasi arterial route despite its configuration being entirely inappropriate for such use. There were serious problems of speeding in Holyrood Park (averaging nearly 40 mph in a 30 mph limit). These problems would not be solved by tinkering with the traffic flow within the village and these supposed solutions which were intended to improve traffic flow and thus encourage more traffic to use this route. The Society had never advocated any of the solutions which officials had put up and the report had neither addressed the real issues nor answered Councillor Ewan Aitken's questions. It highlighted the wrong problems and concluded that it was all too difficult and consequently offered no real answers to the problem.

The main problems was that there were too many vehicles taking this route and because part of it was fast and unregulated, there was a requirement to take enforcement action through the unregulated part of the route through the park and to look at other alternatives such as adjustments of signals and priorities to junctions to encourage traffic to stay on the main routes. In conclusion Miss Crofts stated that there needed to be further analysis undertaken in conjunction with the consultant's report commissioned by the Society to address the issues raised.

(b) Report by the Director of City Development

The Directors of City Development and Services for Communities reported further on concerns regarding Duddingston Village Traffic.

Decision

- That a Member/Officer Working Group to be established to discuss proposals to reduce traffic problems in Duddingston Village. The membership to consist of one member from each political group on the Transport, Infrastructure and Environment Committee, relevant Council officials, the police and a representative from Historic Scotland and Duddingston Conservation Society.
- The Group to produce an interim report to be submitted to the Transport, Infrastructure and Environment Committee in six months.

5 Morningside Road/Bruntsfield Place Parking Restrictions

8 Talking Buses - Motion by Councillor Whyte

- iv) agrees, where possible, within its development of strategy and policy and in discussions with bus service providers to promote the use of audible and visual information systems which announce next stop and final destination information."

Councillor Whyte was heard in regard to this motion.

9 City of Edinburgh Renewable Energy Development Company – Motion by Councillor Burgess

The following motion by Councillor Burgess was submitted in terms of Standing Order 28(3):

"That the Council:

Notes changes to legislation that could allow the Council to generate renewable energy, including from buildings on its estate, and receive revenue for excess electricity generated through a recently introduced feed-in-tariff.

Notes that generating its own renewable electricity could reduce Council energy bills and carbon emissions as well as providing an additional source of revenue for the Council.

Calls for a report on this opportunity including the feasibility of setting up a City of Edinburgh Renewable Energy Development Company."

Councillor Burgess was heard in regard to his motion.

Decision

To approve the motion by Councillor Burgess.

10 Action on Climate Change - Motion by Councillor Burgess

The following motion by Councillor Burgess was submitted in terms of Standing Order 28(3):

"That the Council:

Notes with concern reports to Policy and Strategy Committee and the Cross Party Working Group on Climate Change (CPWGCC) that the Council is failing year-on-year to meet targets to reduce pollution that is contributing to Climate Change.

Notwithstanding the recent decision by the CPWGCC to revise its remit and establish an officer support group.

Calls for the new Chief Executive once in post to be asked to review and make recommendations on improving the Council's governance and management arrangements for Sustainable Development and Climate Change, including having the Sustainable Development Unit report directly to the Chief Executive."

Councillor Burgess was heard in regard to his motion.

Decision

To approve the motion by Councillor Burgess subject to consideration being given to the appropriate location of the Sustainable Development Unit.

11 Waste Minimisation Activities in Edinburgh

- To note from the responses that there was likely to be a requirement for both a capital infrastructure outlay and an ongoing operational subsidy.
- 3) To note that Transport Scotland were unlikely to include in the Cross Forth Passenger Vessel Service in the National Travel Concessionary Fare Scheme particularly in the current financial climate.
- 4) That competitive dialogue procurement for such a service should not proceed at this time.
- 5) To note that both Edinburgh and Fife Councils would work together should any commercial operator be interested in running a future Cross Forth Service.

- To instruct the Director of City Development to commence the statutory process to reduce the existing speed limit on the remainder of the route through to Glenbrook.

- 2) Craiglockhart Road North the path between this road and an access onto the Union Canal (adjacent to Allan Park Road); and

 Cameron Toll Roundabout – a section of path between Cameron March and a signalised cycle coursing of the Lady Road arm of the roundabout.

Decision

To instruct the Director of City Development to initiate and make the necessary re-determination orders for the footpaths under the relevant sections of the Roads (Scotland) Act 1994.

30 George IV Bridge to King's Buildings Quality Bike Corridor – Public Consultation

Details were provided of the outcomes of the recent public consultations carried out for the George IV Bridge to King's Buildings Quality Bike Corridor scheme which would improve facilities for cyclists and bus users travelling between the City Centre, Sciennes and the University of Edinburgh King's Buildings Campus.

Decision

- To note the outcomes of the recent public consultation carried out for the George IV Bridge to King's Buildings Quality Bike Corridor Scheme and that a thorough review of the proposals was currently being undertaken to consider the issues raised.
- 2) To note that three significant issues had arisen from this review to date and the new proposals to address these issues.
- 3) To note that consultation would be undertaken with the Convener of the Committee and with the elected members for affected wards prior to making any major changes to proposals that have previously been reported to the Committee.
- 4) To note that the following the completion of that review process, the statutory procedures necessary to implement the proposals would be undertaken as previously approved by the Committee.

31 20 mph Speed Limit Pilot in South Edinburgh

Details were provided of the results of a consultation exercise for the above proposals for a 20 mph speed limit pilot in South Edinburgh, and approval was sought to commence the statutory procedure to promote the Traffic Regulation Order for a 20 mph speed limit in south Edinburgh.

Decision

- To note the results of the consultation, the comments received and the responses made to these objections.
- To approve the introduction of 20 mph speed limits in south Edinburgh as set out in the report, subject to completion of the necessary statutory procedures.
- 3) To commence the commencement of statutory procedures to introduce a 20 mph speed limit:
 - in the streets indicated with proposed 20 mph speed limits on the plan attached to the Director of City Development's report as Appendix A; and
 - (b) on Ratcliffe Terrace and Causewayside between the junctions with Fountainhall Road and West Preston Street.
- 4) To note the support for increasing the number of streets covered by a 20 mph limit specifically the support for applying the speed limit to the north-south Marchmont Road-Kilgraston Road-Blackford Avenue-West Mains Road-Esslemont Road route and the east-west Churchill -Strathearn Road-Grange Road route.
- 5) With this in mind, to move that these routes be added to the streets to be covered by the 20 mph speed limit.
- 6) To instruct the Head of Transport to contact Neighbourhood Partnerships providing an outline of the proposed pilot inviting them to submit proposals for other pilot areas within their neighbourhood.
- The Head of Transport to qualify with consultees the reasons for including additional streets within the proposals.
- 8) Information on emissions to be included in future reports.
