I may have picked you up incorrectly but did you say yesterday that the SDS/JRC joint and several liability agreement had been executed ? Alan has said that he mentioned this to you yesterday. If this has been done, who signed it, did they have the requisite authority and can we have a copy for our files.

If not, this should be done. Clause 29.8 is drafted as if JRC was executed after the SDS Agreement (this was the original plan) - execution should have happened 10 business days after the execution of the JRC Agreement.

On a separate (but related) point, has someone within the tie team gone through the TSS/JRC/SDS contracts to check that all information/actions which should have been done within fixed time periods - have been or are being done (e.g. broker's letter of undertaking, SDS/JRC getting together etc.)
