The items in question are as follows:

1. Princes Street Supplemental Agreement (subsequently re executed to include DRP provisions)

This was agreed by David Mackay (tie Chairman) with Infraco in late March 2009 to get works restarted on Princes Street. David had discussed and received verbal authorisation from Tom Aitchison (CEC CE) at that time. This was subsequently reported through Tram Project Board.

2. The variation in June 2009 was an output of the mediated agreement to amend schedule part 4 for valuing changes with an agreed 17.5% preliminaries, overhead and profit (this was subject of an early DRP associated with Princes Street and Infraco sought uplifts up to 60% depending on the section of work).

This DRP was settled in formal mediation. Again it was reported through Tram Project Board and I believe was also reviewed at the FCL subcommittee.

3. The April 2010 variation related to putting the tram on Princes Street and its subsequent moves back to the Depot (or another location). .

The requirement to utilise one of the Trams on Princes Street was agreed with TEL, CEC, and **tie** in April 2010. It was reported through Tram Project Board. It is a variation of limited effect and exposure.

All of the above amendments were subject to contemporaneous legal drafting and review by DLA Piper on behalf of tie and CEC.

The above items may have been included in Council reports during 2009 and 2010, I am sure you will be able to check. In the meantime, I will arrange to pull out the various reports and papers included in the TPB in relation to the above.
