Pitchfork - Project Carlisle



- 24/09 tie final offer sent to BSC
- 1/10 BSC implemented action to demobilise subcontractors at a number of sites they claim affected by Change
- 14/10 Letter received from BSC- seemed to indicate that BSC did not wish to continue negotiations on Carlisle
- 19/10 response sent from tie asking each Infraco member to clarify its position
- No response received from individual Infraco Members

Pitchfork - Project Notice



- 10 RTN's and 3 UWN's issued by tie
- 9 RTN rectification plans due 4 received
- · Rectification plans reviewed by tie and rejected
- · BSC claim UWN's not valid
- "Conduct" RTN response received on 10/11
- Consultations with Senior Counsel undertaken on 4/11 and 15/11 with a further series programmed





- CEC/tie decisions workshops held over last few weeks to explore options for :

Pitchfork - DRP (as at 17/11/10)



- 22 items in DRP 13 referred by tie, 9 by BSC.
- 4 resolved by negotiation & 3 resolved through mediation 9 decisions made by Adjudication
- Live DRP's submitted by BSC Landfill tax, Sub-contractors, Preliminaries, Princes Street valuation
- Live DRPs submitted by tie Drainage valuations of Sections 5B & 5C
- Mediations held on Landfill, Sub-contractors and Preliminaries
 no agreement reached so will proceed to adjudication
- Landfill tax adjudication commenced. Sub contractors due to start
- Princes Street mediation planned for 19/11/10



Value of agreed changes £21.163 m



- There were no reportable accidents during the period. The rolling 13 period AFR is at 0.20 still below the target of 0.24 for the project.
- A planned site visit by tie's Insurers took place on 29th October 2010. Whilst the insurers will submit a formal report to tie on their findings, it is understood that no major concerns were raised at the time of the visit.
- No environmental incidents were recorded during Period 8.
- An Environmental Audit at Russell Road was carried out on the 19th October 2010. An
 Environmental Management Plan was issued at the audit but not approved. This will be
 reviewed and actions have already been raised with BSC.



- On 21st October, tie delivered comments back to BSC on the "for info" DAS's, and the initial strategic mapping of the ER's to "the right thing" has been completed.
- In Section 1A (Farrans) handover packs were not fully complete as awaiting sign off of TQ's by SDS. Land Engineering has not yet delivered Handover packs for works carried out.
- The NCR relating to the alignment of the OLE bases at Haymarket has not been closed out.
 Further information has been requested at the BSC progress meeting.
- A CDM Workplace design audit carried out at Gogar Depot was carried out during Period 8.
 No major findings were identified.
- Haymarket Approvals Audit report has been compiled with a number of findings identified.
 Report to be issued to auditees from BSC and CEC for comment prior to formal issue.
- All final documents have now been received for the Clancy Dowcra works at Haymarket.
 Documents currently being reviewed prior to issue to SUC's and BSC.

Code of Construction Practice – Period 08 **Trains**





- Compliance during Period 8 was recorded at 91%. Whilst this represents deterioration in measured compliance from the previous period (99%), this is attributed to more accurate reporting of site conditions following HSQE coaching of those undertaking the checks.
- The recorded breaches mostly relate to housekeeping issues on "mothballed" sites. It is noted that BSC have instigated daily checks at all sites to improve the management of these issues.

Progress

- BSC continue to work at Depot, Section 7 and Depot Access Bridge – but slowly
- tie inspecting all mothballed sites but these are all still under BSC management
- SRU Accommodations Works(Crummock) & South Gyle Access Sewer (Barhale) both completed in Period 8 to programme & budget (both projects were managed direct to tie)

■ In Period 08, an additional £57k has been drawn down leaving a risk allowance of £7.3m.

Trams Progress



- All 27 trams now completed or in production;
- 20, 21, 22, 23 and 24 in finishing area;
- 19th tram undergoing factory acceptance test, CAF have slowed down the production rate;
- 1st and 3rd to 18th trams completed and stored ready for delivery, entitled to take title to all or a selected number.

Operational Readiness Report



- Construction works at the depot 70% complete but momentum is continuing to be lost in the last 2 weeks;
- Building fit-out continues to progress well with LV power and gas connected and commissioning progressing;
- External track works and HV sub-station progressing well although ransom strip around the building being held by BB;
- Depot stabling is able to receive first trams but contractor has refused.
